**ANNOTATED PROVISIONAL AGENDA**

“Governance and gender equity”



## A. BACKGROUND

The Regional Conference on Women in Latin America and the Caribbean is a subsidiary organ of the Economic Commission for Latin America and the Caribbean (ECLAC) consisting of high-level authorities with responsibility for issues relating to the situation of women and for policies to ensure gender equity in the countries of the region. It is the foremost intergovernmental forum in the region for the analysis of public policies from a gender perspective. The Conference is a permanent body convened at regular intervals in fulfilment of the mandates contained in the 1977 Regional Plan of Action for the Integration of Women into Latin American Economic and Social Development and the Regional Programme of Action for the Women of Latin America and the Caribbean, 1995-2001. Both of these documents reflect the regional agenda, which is shaped by the international commitments undertaken at the Fourth World Conference on Women and other world summits.

At their thirtieth meeting, held in Lima in February 2000 during the eighth session of the Regional Conference, the Presiding Officers agreed that one of their two annual meetings should be open to all countries members of the Conference. At their thirty-third meeting, held in Port of Spain, Trinidad and Tobago, in October 2001, they agreed to hold their thirty-fourth meeting in the second half of 2002, since ECLAC would be holding its twenty-ninth session in the first half of the year (Brasilia, Brazil, 6-10 May 2002).

Pursuant to agreement 6 adopted at the Presiding Officers' thirty-third meeting,<sup>1</sup> the deliberations at the thirty-fourth meeting will focus on the analysis of national machineries for the advancement of women in relation to governance and public policies, with emphasis on best practices and successful approaches taken by such machineries.

The Presiding Officers will also consider the main issues to be discussed at the ninth session of the Regional Conference on Women in Latin America and the Caribbean, to be held in 2004, bearing in mind the proposal endorsed in agreement 7, adopted at their thirty-third meeting, to harmonize regional follow-up to the Regional Programme of Action for the Women of Latin America and the Caribbean, 1995-2001, with the 10-year review of the implementation of the Beijing Platform for Action.

### **3. Analysis of the linkages between democratic governance and gender equity**

Under the agreements adopted at the Presiding Officers' thirty-third meeting, it was decided that the participants in the thirty-fourth meeting should discuss the objectives, structure, functions, working methods and outputs of national machineries for the advancement of women, together with their impacts and difficulties, with emphasis on best practices and successful approaches. Accordingly, the secretariat proposes that the deliberations at this meeting should focus on the analysis of national machinery for the advancement of women, governance and public policies.

(a) The secretariat will report on the activities carried out under the project "Capacity-building of national machineries for governance with the gender perspective in Latin America and the Caribbean" (Proposed programme budget for the biennium 2002-2003, section 33, annex, part II D); on the lessons learned in the area of governance under the project on mainstreaming the gender perspective in ECLAC and in sectoral ministries; and on the technical advice and training provided under the inter-agency project on the use of gender indicators in public policy-making.

#### **4. Follow-up to the agreements reached by the Presiding Officers at their previous meetings**

(a) The Cuban delegation will report on the implementation of agreements 1 and 3 adopted at the Presiding Officers' thirty-third meeting. By agreement 1, the States members of ECLAC were called upon to enrich and update their reports on the status of poor women in their countries, taking into account the contributions made during the meeting, in order to provide inputs for the forty-sixth session of the United Nations Commission on the Status of Women (New York, 4-15 March 2002). By agreement 3, the national machineries for the advancement of women represented at the meeting were requested to share the content and findings of the analysis of the issue of poverty conducted at the thirty-third meeting with their countries' ministries of foreign affairs and permanent missions to the United Nations, as a means of contributing to the preparation of the directives to be submitted by each country to the Commission.

(b) The Mexican delegation will report on the implementation of agreements 4 and 5 adopted at the Presiding Officers' thirty-third meeting, in which it was proposed that the national delegations attending the twenty-ninth session of ECLAC (Brasilia, Brazil, 6-10 May 2002) should include authorities responsible for gender policies in their countries, and the Chairperson of the Presiding Officers was requested to submit the agreements adopted at their thirty-first, thirty-second and thirty-third meetings for the consideration of the delegations at that session.

(c) Pursuant to agreement 9 adopted at the Presiding Officers' thirty-third meeting, the ECLAC secretariat will inform the countries of the agenda of future regional, subregional and international meetings relating to women's and gender issues so as to avoid any duplication of effort and facilitate planning.

(d) The countries of the region represented by the Presiding Officers will report on the process of signing and ratifying the Optional Protocol to the Convention on the Elimination of All Forms of Discrimination against Women, in accordance with agreement 7 adopted at the Presiding Officers' thirty-second meeting, under which they agreed to call upon the legislative bodies of the countries that had not yet done so to expedite completion of the procedures leading to the signature, approval or ratification of that instrument.

(e) Pursuant to agreement 5 adopted at the Presiding Officers' twenty-eighth meeting, the representatives of specialized agencies and other organizations of the United Nations system and intergovernmental organizations will submit written reports on the activities they have carried out since the Presiding Officers' preceding meeting, along with oral reports on their activities in relation to the linkages between democratic governance and gender equity.

**5. Planned activities of the Presiding Officers and the ECLAC secretariat with a view to preparations for the ninth session of the Regional Conference on Women in Latin America and the Caribbean**

(a) The secretariat will report on the proposal submitted by the Government of Mexico at the twenty-ninth session of ECLAC to host, in 2004, the ninth session of the Regional Conference on Women in Latin America and the Caribbean. Tentative dates will be proposed for the convening of that session.

(b) The Presiding Officers will consider a proposal from the secretariat on the substantive issues that could serve to guide the deliberations at the ninth session of the Regional Conference on Women in Latin America and the Caribbean with a view to harmonizing regional follow-up to the Regional Programme of Action for the Women of Latin America and the Caribbean, 1995-2001, with the 10-year review of the implementation of the Beijing Platform for Action.

(c) The Presiding Officers will take decisions concerning their future activities.

**6. Other matters**

Under this item, the delegations will consider any other issues they may wish to raise.
