FIFTH CONFERENCE OF MINISTERS AND HEADS OF PLANNING  
OF LATIN AMERICA AND THE CARIBBEAN

Organization and Proposed Agenda 1/

A. At the Fourth Conference of Ministers and  
Hheads of Planning of Latin America and the Caribbean  
BACKGROUND (Buenos Aires, 9-10 May 1983), the Government of  
Mexico offered Mexico City as the site for the next  
Conference. This proposal was unanimously approved  
by the Plenary.

The Latin American Institute for Economic and  
Social Planning (IIPES) will serve as the Technical  
Secretariat of the Conference, and will organize it  
in co-operation with the Secretariat for Programming  
and Budget of Mexico and with the support of the  
Secretariat for Foreign Affairs of that country.  
This work falls within the scope of the regular  
programme of activities of the Conference Officer  
and the Secretariat of the Economic Commission for  
Latin America and the Caribbean. At the local level,  
the United Nations will provide support services  
through the ECLAC Office in Mexico and the UNDP  
Office.

In accordance with the mandates of the governments, the Technical Committee of ILPES will also meet during the Conference. The Technical Committee is made up exclusively of the heads of delegation of the planning ministries and national planning agencies of the 37 member countries participating. (See Document LC/IP/R.49 CT 6/2).

Thus, the Fifth Conference will be held in Mexico City on Monday 15 April, Tuesday 16 April and the morning of Wednesday 17 April 1985. The Sixth Session of the Technical Committee of ILPES will begin on Tuesday morning, 16 April. This document contains information basically on the first of these events.

B.

DURATION

In keeping with established practice, the Conference will have a duration of two and a half days. Therefore, as was the case with the previous Conference, the relevant documentation will be distributed in advance in order that member countries may have time to send their suggestions to the Institute before April 1985.

At the same time, it is possible that the agenda of the Sixth Session of the Technical Committee will be completed in one or two meetings, with the personal attendance of the Ministers and Heads of Planning.



E.

WORKING  
GROUP

An ad hoc working group will be organized to study in greater detail two other items that are directly related to the mandates received by the Institute, as follows:

- "Centralization and decentralization in governmental decision-making".
- "Employment, income and social programmes during the second half of the decade".

A plenary meeting will be reserved for receiving and discussing the conclusions reached at the two meetings of the Working Group. Because of the limited time available for the Fifth Conference, it will be essential that this group begin meeting at the same time as the official meeting of the Sixth Technical Committee.

F.

ATTENDANCE

With respect to the 37 member countries, confirmations already received by the Institute from countries of the Central American Isthmus, the Caribbean and South America indicate that the Conference will be well attended by governmental representatives. In accordance with official recommendations, a formal invitation will be sent to the Ministries of Foreign Affairs to send observers.<sup>3/</sup>

As has already become traditional, it is expected that observers from certain international agencies, technical co-operation agencies and other organizations concerned with planning and development policies in the region will also attend. Special invitations may also be sent to entities of non-member countries from outside the region that are interested in the work being done by ILPES and with which the region may wish to expand the exchange of experiences regarding planning and development. The Conference will be open to observers from public agencies concerned with monetary and financial matters in the member countries.<sup>4/</sup>

G. ARRIVAL OF DELEGATIONS

The Fifth Conference will be inaugurated on Monday morning, 15 April, and will close at the end of Wednesday morning, 17 April. Nevertheless, registration of participants will take place on Sunday afternoon, 14 April, at which time documentation prepared for ad hoc distribution will be delivered. This schedule - prepared in keeping with suggestions of member governments - will enable delegations to use the preceding weekend to travel to Mexico City.

H. SIXTH SESSION OF THE TECHNICAL COMMITTEE

The Sixth Session of the Technical Committee of ILPES, to be attended by the heads of delegations sent by the planning ministries or national planning agencies, will be held within the context of the Fifth Conference. Since there is a possibility of

a technical meeting being held parallel to the Sixth Session of the Technical Committee, it is recommended that, insofar as possible, countries should send at least one other person to accompany the Minister or Head of Planning.

This forum provides the opportunity for the governments to conduct an overall appraisal of the New Institutional Project of ILPES for 1984-1986,<sup>5/</sup> with emphasis on the Programme of Work for 1985.

I.                   The local organizers suggest that all delegations stay at the Camino Real Hotel; the Mexican Government will provide transport facilities from there to the Conference site. Reservations should be confirmed as far in advance as possible. Information concerning hotel prices will be sent to participants as soon as possible.
