Introduction

The Economic Commission for Latin America and the Caribbean has been carrying out studies on the status of women in the region on a systematic basis since 1975. These studies, which are undertaken in response to ECLAC's concern with the role of women in the development process, have covered a wide range of topics, including, *inter alia*, social aspects of the subject, demographic factors, the participation of women in education and in employment, and the roles of women in the family, in politics and in social movements.

National diagnostic analyses have been prepared and policy guidelines have been formulated. National, subregional and regional projects have been designed, assessed and executed. The results of this work have been presented at governmental, academic or expert debates and have ultimately led to the publication in book form of research findings concerning specific groups of women, women in the most vulnerable sectors, young women, women in urban and rural low-income sectors, etc.

With a view to systematizing the already substantial amount of information that has been gathered, this updated bibliographic list of the main studies carried out during the past 13 years has been prepared for those interested in the subject.
