ANNOTATED PROVISIONAL AGENDA

A. BACKGROUND

The Regional Conference on Women in Latin America and the Caribbean is a subsidiary body of the Economic Commission for Latin America and the Caribbean (ECLAC). It brings together Government representatives to monitor compliance with international and regional agreements on gender equality.

In consultation with the Government of Ecuador, Chair of the Presiding Officers elected at the tenth session of the Regional Conference on Women in Latin America and the Caribbean, it was agreed to convene the forty-second meeting of the Presiding Officers on 4 and 5 December 2008 in Santiago.

At this meeting, the Presiding Officers will concentrate mainly on reviewing progress in setting up the gender equality observatory for Latin America and the Caribbean¹ in accordance with the Quito Consensus. In particular, participants will consider the results of the meetings convened in Aguascalientes, Mexico, on 2 and 3 October 2008 and in Trinidad and Tobago on 6 and 7 October 2008 to analyse the indicators of the observatory, as requested at the last meeting of the Presiding Officers by member countries whose representatives serve in that capacity.²

The Presiding Officers will consider the preparations being made for the eleventh session of the Regional Conference on Women in Latin America and the Caribbean, to be held in Brazil in June 2010; the progress made within the region in implementing the Secretary-General's campaign to eliminate all forms of violence against women; and the status of the reforms to the gender architecture of the United Nations system.

2. Analysis of the impact of the economic and financial crisis on the situation of women in Latin America and the Caribbean

The secretariat will present the report of the technical meeting of gender statistics experts for the analysis of the indicators for the gender equality observatory, held in Aguascalientes, Mexico, on 2 and 3 October 2008.

The ECLAC subregional headquarters for the Caribbean will present the results of the Caribbean technical meeting on the establishment of a gender equality observatory for Latin America and the Caribbean, held in Port of Spain on 6 and 7 October 2008.

The secretariat will report to the Presiding Officers on the inter-agency agreements, financial resources and preparation of the website relating to the establishment of the gender equality observatory for Latin America and the Caribbean.

The secretariat will present a proposal on the functioning of the observatory to the Presiding Officers for analysis.
