


ACTIONS TAKEN




1. Paragraph 24. A new agreement was signed in December 1972 with the University of Costa Rica for the continuation of the Sub-Centre and for the provision of new premises.
2. Paragraph 25. During ECLA's Fifteenth Period of Sessions, alternates were elected for the two principal representatives of governments appointed on that occasion. The International Union for the Scientific Study of Population -which will not be represented at this session- was requested to appoint an alternate representative, but the Union indicated its impossibility of doing so.
3. Paragraph 31. Whenever possible, recommendations have been made to the government agencies, suggesting that they include fellowships to pursue demographic studies at CELADE within their respective national programmes. This measure does not seem to be, however, the most effective. Perhaps it would be advisable that the Chairman of the Board would address himself formally to the national institutions responsible for technical assistance.
4. Paragraph 39. During 1973, explorations will continue with other departments of the University of Chile regarding the possibility of developing other post-graduate programmes in demography.
5. Paragraph 45. The undertaking of any study which would enable to submit to the Governing Board the document requested has been postponed until decisions in firm have been taken regarding the future of CELADE after March 1974.
6. Paragraph 47. The fulfillment of this recommendation will depend on the proposals contained in the document to which reference is made in item 5 above.
7. Paragraph 50. Some exchange has already been started by the Sub-Centre. Further activities would depend on CELADE's continuation.



8. Paragraph 53. In view of the uncertainty of CELADE's future, an effort has been made not to start in 1973 or 1974, new areas of research that would require additional financing. If this situation is solved, special attention would be paid in the future to studies in rural areas.
9. Paragraph 53. CELADE will not continue studies on historical demography. The "Instituto Mexicano de Antropología e Historia" seems interested in pursuing this line of research. To this end, negotiations will be started with the Institute.
10. Paragraph 53. CELADE continues working with the demographic submodel.
11. Paragraph 55. See the Report of the Group of Experts on ECLA's Population Programme, ST/ECLA/Conf.46/L.2/Rev.1.
12. Paragraph 56. CELADE is awaiting the proposals that the U.N. Population Division might formulate in this connection.
13. Paragraph 74. The recommendations contained in this paragraph were, in general, carried out. They were opportunely transmitted by the President of the Board to the U.N. Office of Technical Co-operation. The Mission of Evaluation visited Santiago Headquarters and the Sub-Centre on February and March 1973. Excerpts of the Mission's preliminary report are submitted to the Board in document CD6/7. However, the schedule recommended by the Board could not be met, due to the fact that ECLA's session took place at the end of March instead of late April as had been anticipated.
