II. ANNOTATIONS ON THE PROVISIONAL AGENDA

2. Adoption of the agenda

3. <u>Economic evolution of the region since the twenty-second session of ECLAC: main events</u>

In this agenda item, for which the Secretariat prepared document IC/L.492, an analysis will be made of the main events which have affected the economic evolution of Latin America and the Caribbean in 1988 and the ways in which these events may influence the economic development of the region in the future. In view of what was decided by ECLAC in its resolution 492(XXII), special attention will be given in this analysis to recent events in both debtor and creditor countries connected with the external indebtedness of the region.

4. <u>Preparation of the new International Development Strategy for the Fourth</u> United Nations Development Decade

The Secretariat has prepared a document (IC/L.494(PLEN.20/4)) containing the information on the preparation of a new International Development Strategy requested by the Commission in resolution 498(XXII).

This document includes elements of analysis which it is hoped will contribute to the debate within CEGAN on the scope and content of the new IDS. In this respect, it may be recalled that at its forty-third session the General Assembly adopted resolution 43/182 setting up an <u>ad hoc</u> committee of the whole and putting in motion the necessary institutional machinery for the preparation of a new International Development Strategy.
