CONSIDERATION OF THE RAPPORTEUR'S REPORT (Conference room paper N°36)

Mr. PALACIOS (Guatemala), speaking in his capacity as Rapporteur, read out the report of the Committee's work.

After an exchange of views in which Mr. GARCIA INCHAUSTEGUI (Cuba), Mr. RIOSECO (Chile), Mr. SAMPER (Colombia), Mr. CALDERON (México), Mr. PEÑA (El Salvador), Mr. MIDWINTER (Canada) and Mr. DEUSTUA (Peru) took part, it was agreed to appoint a working group consisting of the representatives of Mexico and Venezuela in order to incorporate the various comments in the text of the report to collaborate with the Rapportaur and the Secretary.

The meeting was suspended at 5.15 p.m. and resumed at 11.25 p.m.

Mr, PALACIOS (Rapporteur) read out the revised text of his report embodying the suggestions made by the working group.

Mr. GARCIA INCHAUSTEGUI (Cuba), Mr. CALDERON (Mexico),
Mr. DEUSTUA (Peru) and Mr. FALUII (United States), made various
comments designed to improve the drafting, but not affecting
the substance of the report.

Mr. MENDEZ (Secretary of the Committee) welcomed the comments and undertook to embody them in the text of the report, since they had been accepted by the Rapporteur.

On a vote being taken, 12 votes were cast in favour and none against; consequently the report was approved unanimously.
