INTRODUCTION

The Ad Hoc Working Group established pursuant to resolution 553(XXVI) of the Economic Commission for Latin America and the Caribbean held one meeting during the period under review in accordance with resolution 578(XXVIII), wherein the Commission approved the programme of work for the ECLAC system for the biennium 2002-2003 and requested the Ad Hoc Working Group to continue to collaborate with the Executive Secretary in setting priorities for the programme of work and in the debate and analysis of strategic directions for the future activities of the Commission.

Accordingly, the sixth meeting of the Ad Hoc Working Group was held in Santiago, Chile, on 30 and 31 August 2000 to define the priorities of the programme of work of the ECLAC system, which had been adopted at the twenty-eighth session in Mexico. It was attended by representatives of 24 member States. ECLAC division directors and the main officers responsible for the execution of the different subprogrammes introduced them and drew attention to the most important subject areas. The floor was then declared open for debate on the establishment of priorities. Some changes were made in the order of priority given to some activities on the programme of work, as reflected in the report of the meeting (LC/G.2131(GET.6/3)).

During the general discussions, participants commented on the much more favourable climate for setting priorities compared with the situation that had prevailed at earlier meetings of the Ad Hoc Working Group, when budgetary constraints made it highly uncertain whether some of the scheduled activities listed in the respective subprogrammes of work would ever be implemented. Several delegations urged the secretariat to adapt the methodology applied in its studies so that small countries could be treated as a separate category; some wished to see greater priority given, within the programme of work, to the problem of natural disasters. Another delegation stressed the importance of reflecting in the programme of work the spirit of the resolution on equity, development and citizenship within the framework of the commitment adopted by countries at the twenty-eighth session of the Commission.

The ECLAC secretariat reported on the advances made in modernizing internal management procedures since the previous meeting and suggested that it might be appropriate to reflect on the relevance of the Group's mandate and on whether it should be adapted to reflect the new working conditions existing within the Commission.

In the two previous bienniums, the Ad Hoc Working Group had sought to fulfil its mandate by first considering issues relating to the programme of work and subsequently dealing with the modernization of internal management procedures. However, although work on modernization had continued during the biennium under consideration, no changes had occurred during the second half of the period to warrant convening a meeting of the Group. Thus, bearing in mind that such issues could be addressed at the twenty-ninth session, the Chairman of the Group, in consultation with the ECLAC secretariat, decided not to convene a meeting in 2001.

1. Mandate

1. Pursuant to resolution 553(XXVI) adopted at its twenty-sixth session, the Economic Commission for Latin America and the Caribbean (ECLAC) established an ad hoc working group open to all ECLAC members. The group, in consultation with the Executive Secretary, is empowered to define priorities for the work programme and to recommend to the Commission strategic directions for its future activities, taking into account development priorities for Latin America and the Caribbean as well as budgetary considerations. The mandate was renewed by the Commission in its resolution 565(XXVII), adopted at its twenty-seventh session, and in its resolution 578(XXVIII), adopted at its twenty-eighth session.

2. Place and date of the meeting

2. The sixth meeting of the Ad Hoc Working Group was held in Santiago, Chile on 30 and 31 August 2000.

3. Attendance¹

- 3. The meeting was attended by representatives of the following States members of the Economic Commission for Latin America and the Caribbean: Argentina, Bolivia, Brazil, Chile, Colombia, Costa Rica, Cuba, Dominican Republic, Ecuador, France, Guatemala, Haiti, Italy, Mexico, Netherlands, Nicaragua, Panama, Paraguay, Peru, Portugal, Spain, United States, Uruguay and Venezuela.
- 4. The meeting was chaired by Ricardo Cámara, Director General, Office of Economic Relations with Latin America, and Asia and the Pacific, in the Ministry of Foreign Affairs of Mexico.

5. Summary of proceedings

(a) General discussions

- 6. The Chairman of the Ad Hoc Working Group, in declaring open the meeting, expressed satisfaction at being able to participate in its deliberations and stated that ECLAC had earned the appreciation of all the countries in the region. In recent years, it had successfully adapted its role in line with the enormous changes occurring within the region and the challenges that they entailed. Indeed, it was the only organization devoted systematically to the study of development issues in Latin America and the Caribbean, combining its analytical work with the dissemination of specialized information, the provision of advisory services and training and support for regional and international cooperation. ECLAC had thus established itself as an economic think-tank for Latin America and the Caribbean.
- 7. At the close of its twenty-eighth session in Mexico in April 2000, the Commission had adopted the programme of work for the biennium 2002-2003 and had renewed the mandate of the Ad Hoc Working Group, thereby enabling it to pursue its collaboration with the Executive Secretary in setting priorities for the programme and to contribute to discussions and analyses of the strategic course of action to be adopted for the future. The current meeting, which was taking place in much more favourable conditions than in the past, promised to be of great value and yet another example of the Group's relevance and of the high level of consensus among member countries and the Executive Secretary of the Commission in determining priorities.
- 8. The Executive Secretary of ECLAC made certain general observations on the Commission's activities. He gave a brief outline of the principal meetings that had been held since the twenty-eighth session in Mexico, in particular, the second Regional Conference in Follow-up to the World Summit for Social Development, held in Santiago, Chile and the Regional Meeting on Information Technology for Development, held in Florianópolis, Brazil, which culminated in a declaration which had served as an important input at the recent session of the Economic and Social Council.
- 9. Among the planned activities referred to by the Executive Secretary were the Latin American and Caribbean Regional Consultation on Financing for Development, scheduled to be held in Bogotá, the Regional Meeting in Follow-up to the United Nations Conference on Human Settlements (Habitat II) and the meeting of the Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean.
- 10. Turning to other areas, the Executive Secretary reported on the full incorporation of the Latin American and Caribbean Institute for Economic and Social Planning (ILPES) within ECLAC, a measure of particular relevance for its training activities, and pointed to the use of new facilities in that area. He also mentioned the establishment of the ECLAC office in Bogotá and the support activities provided for the Summit of the Americas and the Free Trade Area of the Americas in ensuring full complementarity between the work of ECLAC and the interests of the countries participating in that process. He also drew attention to the incorporation of performance indicators in the Commission's programme of work.
- 11. The Executive Secretary drew attention to the dissemination activities being carried out by the Commission to project its activities and publications, both in print and electronic form. A new uniform style had been adopted for the graphic design of the publications and a dynamic line of publications were being produced jointly with commercial publishing houses. Indeed, significant progress had been achieved in that area. With respect to electronic publications, visits to the ECLAC Web site had

increased exponentially, and the site was currently being redesigned to reflect the veritable revolution being recorded in the field.

- 12. The Regional Advisor on International Communications for Development in the Programme Planning and Operations Division made an audiovisual presentation on the changes to the ECLAC Web site and the incorporation of new technologies. He quoted statistics on the growing number of visitors to the site and on the documents downloaded from the Web, which had led to a significant increase in the number of subscribers to the various publications, confirming the relevance of the Commission's work. Plans for the future included increasing the dissemination of documents, making the ECLAC Web site more user-friendly and adding new services, in order to better serve the Governments and institutions in the region.
- 13. During the general exchange of views among delegations, participants congratulated ECLAC on the progress achieved in the last biennium and expressed support for the direction of its work. Several delegations stated their satisfaction with the advances in the Web site design, but stressed that technological diffusion should not replace diffusion by traditional methods, since not all countries had equal access to the necessary electronic facilities. One delegation proposed setting up a directory of national agencies that possessed databases on indicators in each country and suggested that such a directory, including the electronic address of the relevant agencies, might be published through the ECLAC Web site, to facilitate direct contact with them.
- 14. Attention was drawn to the importance for countries to remain in constant touch with the ECLAC secretariat to ensure that the region's priorities were duly reflected in the programme of work. Clear-cut procedures should be established to govern coordination and interaction between the secretariat of the Commission and regional and subregional integration groupings in Latin America and the Caribbean.
- 15. Several delegations urged ECLAC to adapt the methodology applied in its studies so that small countries could be treated as a separate category.
- 16. Various delegations wished to see greater priority given, in the programme of work of ECLAC, to natural disasters to which many countries of the Central American and Caribbean subregions were particularly at risk. One delegation suggested that the work in that field should not be limited to the ravages caused by hurricanes but should encompass other phenomena, such as earthquakes and droughts, whose consequences were dramatic. It therefore advocated the establishment of technical assistance programmes for different disasters scenarios. In that connection, one delegation specifically requested that a permanent programme should be set up with special staffing and resources for studying natural disasters and providing assistance to countries.
- 17. One delegation reiterated the importance for the programme of work to reflect the spirit of the resolution on equity, development and citizenship, within the framework of the commitment made by countries at the twenty-eighth session of the Commission in Mexico.
- 18. At the enquiry of some delegations, the ECLAC secretariat recalled that the meetings of the Ad Hoc Working Group had been held in Santiago to enable delegates of member Governments to examine the priorities of the programme of work with the participation of the directors of the divisions responsible for the different subprogrammes. On the other hand, when the purpose of the meetings was to analyse the reform process in the United Nations, its impact on the Commission generally and reform of management

procedures in ECLAC, in particular, the Ad Hoc Working Group had met at United Nations Headquarters in New York, to allow for the participation of officers from the permanent missions of Member States to the United Nations, who had a thorough knowledge of the General Assembly resolutions and the provisions of its subsidiary bodies that had a bearing on the work of ECLAC. In that connection, the Chairman of the Ad Hoc Working Group recalled the original mandate contained in resolution 553(XXVI) and stated that any country desirous of changing that or any other aspect of the Group's work should put forward a recommendation at the next session of the Commission scheduled to be held in Brazil in 2002.

- 19. The delegation of Mexico, with support from the Netherlands, wished to have placed on record their request for meetings of the Ad Hoc Working Group to be held outside of Santiago. That delegation also proposed that the ECLAC secretariat should initiate consultations on modernization of the mechanism to ensure greater transparency and efficiency and to avoid the duplication of work with other bodies in preparation of the work programme.
- 20. The Deputy Executive Secretary thanked participants for the enthusiasm shown in the analysis of the priorities of the programme of work. The work carried out was extremely valuable, since it gave a greater degree of fulfilment to a process initiated in 1999, three years before the programme was to come on stream. At the same time, it was a complex exercise as it was easy to confuse the concept of "priority" with that of "appreciation". The Commission had used the expression "relative priority" in the classification of the scheduled activities, which helped to explain that it was not a matter of treating one activity as being more or less important than another.
- 21. Reference was made to the role fulfilled by the Ad Hoc Working Group since its inception at a time when, unlike the current situation, budgetary constraints were particularly acute, and when the implementation of some scheduled activities could have been jeopardized, hence the importance of establishing priorities. It would perhaps be appropriate to reflect on the relevance of the group's mandate and on the need to adapt it to the new working conditions existing in the Commission.
- 22. The Chairman of the Ad Hoc Working Group closed the meeting with an expression of thanks to all the delegations for their spirit of willingness, which had enabled the Group to cover a wide range of issues within a very short space of time.

(b) Review of subprogrammes

- 23. In presenting the subprogrammes, the directors of divisions and the main officers responsible for their implementation drew attention to the most important areas of work. This presentation opened up the discussions on the establishment of priorities.
- 24. One delegation suggested that the secretariat should take into consideration the issue of incentives for retooling of productive enterprises under subprogramme 2. With reference to subprogramme 3, it would be appropriate to focus on the coordination of the fiscal and financial policy in the area of decentralization. Another delegation was of the view that the issue of fiscal federalism, which perhaps should be dealt with in some one of the studies under consideration for the next biennium in that subprogramme. A recommendation was put forward for institutionalization of population policy in subprogramme 6 and coordinating development with demographic, economic and environmental variables and sustainable land-use management (subprogrammes 6, 8 and 9).

- 25. With reference to subprogramme 7, one delegation suggested strengthening public sector programming in a multi-year framework, bearing in mind that that sector had acquired greater importance in recent years.
- 26. Several delegations drew attention to the vulnerability of the countries of the Caribbean, in terms not only of geographic location but also of their economic and social conditions, and, in particular, their trade linkages with the rest of the world. They advocated giving greater priority to training activities to enable local officials to take responsibility for natural disaster mitigation and for coordinating tasks when such disasters arose. The subregion should be much more closely integrated into the work of the Commission, a situation which would be reflected in a greater number of projects and programmes for the countries in question.
- 27. In reply to an enquiry from one delegation, the Director of the ECLAC Subregional headquarters for the Caribbean reported that that office was working in close collaboration with the Association of Caribbean States to which it was providing technical assistance on a constant basis in a wide range of fields. Strong ties had also existed with the Caribbean Development Bank, which in recent years were centred mainly on activities directed towards poverty eradication.
- 28. With respect to subprogramme 5, various delegations expressed an interest in obtaining gendersensitive statistics and demographic studies.
- 29. The delegation of Nicaragua referred to the customs union between Guatemala, Nicaragua and El Salvador, an issue, which should, in its view, be taken into account in any study of ECLAC. It would also be very useful to carry out studies on the possible link between the integration process in Central America and the Free Trade Area of the Americas.
- 30. The Director of the Programme Planning and Operations Division explained that activities for the subregions of the Caribbean, and Mexico and Central America were provided for under all the subprogrammes but not limited to the activities appearing on those lists.
- 31. Annex 2, entitled "Changes suggested by the Ad Hoc Working Group to the order of priorities proposed by the ECLAC secretariat for the implementation of the programme of work of the ECLAC system, 2002-2003" sets forth the changes proposed by the Ad Hoc Working Group.
