A. ORGANIZATION OF WORK

Place, date and purpose

1. The sixth session of the Regional Conference on the Integration of Women into the Economic and Social Development of Latin America and the Caribbean was convened by the Executive Secretary of ECLAC in fulfilment of ECLAC resolution 509(XXIII). The purpose of the Conference was to adopt the Regional Programme of Action for the Women of Latin America and the Caribbean, 1995-2001, and to serve as the regional preparatory meeting for the Fourth World Conference on Women, to be held at Beijing in 1995.

Attendance¹

2. Organization of work

15. Plenary meetings were held to consider agenda items 1 to 6 and 8 to 11. Item 7 was considered by a Working Group, and the results of its work were submitted to the plenary meeting.

Opening meeting

16. At the opening meeting, the floor was taken by President Carlos Saúl Menem of the Argentine Republic, Mrs. Gertrude Mongella, United Nations Assistant Secretary-General and Secretary-General of the Fourth World Conference on Women; and Mr. Gert Rosenthal, Executive Secretary of ECLAC.

17. The Executive Secretary of ECLAC thanked the Governments of Argentina and of the other member countries, as well as the Secretary-General of the Fourth World Conference on Women, for their support and participation. He noted that the sixth session of the Regional Conference on the Integration of Women into the Economic and Social Development of Latin America and the Caribbean should be seen as part of a process that called for ongoing evaluation to respond to the extraordinary changes that had taken place in fields such as international relations and the functioning of the world economy, whose globalization had changed the Latin American and Caribbean countries' approach to development, in a context of increasingly pluralistic and participatory political regimes, though the region still faced the challenge of addressing a large backlog of social problems.

18. As a result of those changes, the issue of women's right to participate fully in development was also being approached in a very different way and with greatly expanded knowledge of its multiple dimensions in the fields of education, health care, employment and politics. With respect to the progress made to date, he noted the widespread interest in gender equality, the virtual elimination of open discrimination and the proliferation of non-governmental organizations working in that field, which showed that women's role in society was not only growing, but also becoming more visible. Another important change was that the issue of women's participation was no longer a relatively isolated area based on the formulation of demands; it had become an aspect of the broader issue of development, which meant that it also covered changes in the historically and culturally established relationships between women and men, and therefore placed gender equality in the more general context of social equity objectives and the political agendas of Governments. That had prompted the ECLAC secretariat to stop confining the issue to a specific organizational division and to incorporate it increasingly into the economic, social, cultural and environmental spheres of action. In addition, more national, regional and

international instruments were currently in force, and all of the countries had established special institutional authorities to carry out specific activities to improve the many facets of the situation of women.

19. Those changes formed the backdrop for the sixth session of the Regional Conference, which differed from previous sessions in many ways, *inter alia* because virtually all of the countries had submitted national reports, which depicted the heterogeneity of national situations, with the result that the issue of public policies for women could be addressed more effectively. Moreover, the participants would not simply draw up a list of problems; instead, they would identify specific priorities that were consistent with the ECLAC proposal on changing production patterns with social equity.

20. The draft Regional Programme of Action for the Women of Latin America and the Caribbean, 1995-2001, which was expected to constitute an important input for forthcoming international forums, had two basic premises: that activities targeting women should be designed within the overall framework of the region's development and not as isolated aspects of that development, and that it was necessary to focus on the definition of a basic package of measures that all the countries were willing to implement. Those measures covered six spheres of action: gender equity; social integration; alleviation and reduction of poverty; participation in decision-making and the exercise of power; human rights, peace and violence; and shared family responsibilities. Lastly, he said that the meeting would launch a phase of action that included implementing mandates and recommendations, exercising the rights acquired, trying out new and broader labour structures, making qualitative changes and involving both women and men in a process of joint reflection on how everyone could help to build a more equitable, more just and more equally shared world.

21. The Secretary-General of the Fourth World Conference on Women, to be held at Beijing in 1995, said that many regional and subregional activities preparatory to the Conference had been successfully carried out under the leadership of the secretariat of the Economic Commission for Latin America and the Caribbean. The Fourth World Conference would take place at a very crucial point in time, being one of a series of United Nations conferences on such issues as environment, human rights, population and social development. Moreover, it would be held during the fiftieth anniversary of the United Nations, at a time when the Organization was confronted with the urgent task of seeking a new development paradigm aimed at establishing a stable, peaceful world, strengthening the voice of the poorest members of society, safeguarding human and minority rights, rescuing States in crisis and overseeing the repair of the damaged world environment.

22. The roles of women and men were in a period of transition, with traditional approaches to gender relations giving way to more equitable partnerships. As part of that process, the focus of the United Nations Commission on the Status of Women had shifted to the advancement of women in a broader, development-based approach. The United Nations had spearheaded the globalization of the women's movement by declaring 1975 as International Women's Year and by sponsoring three world conferences on women, held in Mexico City, Copenhagen and Nairobi respectively. The Fourth World Conference would evaluate the progress made in the advancement of women and would take positive action to ensure that issues of concern to women, and ultimately to the entire world, were kept high on the international agenda.

23. To combat the "feminization of poverty", extensive changes in policy, government, business and the household would be necessary. In large part, women had been the ones who had paid for structural adjustment. Their productive, reproductive and community managerial capacities had been exploited,

placing greater demands on their lives. Paradoxically, the positive aspect of gender imbalance was that poor women as a group had been discovered as reliable partners for social investment. Dealing with poor women entrepreneurs and producers had been recognized as an effective means to eliminate poverty, encourage entrepreneurship and reach an emerging market.

24. The Latin American and Caribbean region, by unanimously ratifying the Convention on the Elimination of All Forms of Discrimination against Women, had taken the first step to ensure the implementation of the commitments made in Nairobi. The Fourth World Conference had the responsibility of assessing the role of women in the decade since the Nairobi Conference not only as poverty fighters but as key players in the attempt to devise a new development paradigm and a new social charter. She challenged the Regional Conference, as part of the preparatory process for the Fourth World Conference, to confront that responsibility.

25. The President of the Argentine Republic, after having welcomed the delegations participating in the Conference, said that the current juncture was very significant and of crucial importance for the future of women throughout the world. Women had been waging a struggle over a very long period of time to eliminate discrimination against them and achieve equality with men, and it would take a long time to give an account of that struggle. What was important now was to decide what to do in order to progress towards equality of men and women in the near future —a difficult but necessary and just task. Men by themselves could achieve nothing; they needed women by their side, on an equal footing, in order to deal with the scourges that afflicted humankind. Action must be taken in the areas of health and education, but above all with regard to poverty, particularly extreme poverty. In Latin America and the Caribbean, over 200 million out of a population of 450 million were living in poverty. That was so everywhere, including Argentina; the country was making progress in solving the problem through growth and development.

26. Among the steps taken in Argentina to ensure that women achieved equality with men, he mentioned universal suffrage, an achievement attained in the 1950s after a lengthy struggle. He also stressed other more recent measures, such as the establishment in 1991 of the National Council for Women, which reported to the Office of the President and kept the President informed of the demands being made by women; the establishment of an office of women consultants to the President; and the signing of an agreement between the Government and women on equality. With that and other measures, progress was being made towards equality of opportunity in the areas of education, culture and participation in the labour force. In order to fulfil that task, it was essential to give women the opportunity to become members of Parliament; accordingly, the Quota Act had been passed, and a statutory decree had been issued for its implementation in the 1993 elections. The Act specified that 30 per cent of elective posts should be set aside for women, which had increased the number of female members of Parliament, at both the national and the provincial level. He stressed that in the reform of the 1953 Constitution recently carried out in Santa Fe, 80 out of a total of 302 women had argued strongly that the Constitution should protect and guarantee the rights of women, children and families. The Argentine Constitution had given constitutional status to the Convention on the Elimination of All Forms of Discrimination against Women, and Argentina was the only country in the world that had done so. The Constitution also contained a provision permitting the establishment by law of affirmative measures for the benefit of women, the elderly and the disabled. That was all in keeping with the message that Argentine women would take to the World Conference, so as to ensure that the spirit of the agreement on equality signed in his country spread throughout the world.

27. He expressed his respect and personal admiration for women, as well as satisfaction that his country was hosting the sixth session of the Regional Conference. Lastly, he underlined that although great progress had been made towards political equality in Argentina, much remained to be done in the economic sphere —for example, in the area of business management, where inequality persisted. Saying that his country would continue to support the cause of equality for women in the region and in the world, with action and not just words, he declared open the sixth session of the Regional Conference on the Integration of Women into the Economic and Social Development of Latin America and the Caribbean.

Adoption of the report of the meeting

28. The delegation of Mexico, acting as rapporteur, introduced the draft report of the meeting, which was adopted.

Closing meeting

29. At the closing meeting, statements were made by Ms. Guadalupe Jerezano, Vice-Chairperson from Honduras, on behalf of delegations; by Ms. Miriam Krawczyk, Chief, ECLAC Women and Development Unit; and by Ms. Zelmira Regazzoli, in her capacity as Chairperson of the Presiding Officers.

30. The Honduran Vice-Chairperson expressed gratitude to the Government of the Argentine Republic and its President, as well as to ECLAC, to the private development agencies and to the non-governmental organizations, for their contribution to the conduct of the meeting. The Conference had been an extraordinary experience, involving highly enriching analysis and discussion, despite the differing views on how to achieve the shared objectives of the women of Latin America and the Caribbean. The efforts undertaken to achieve gender solidarity were worthy of special mention, as they demonstrated the progress made by women in the region over recent years; that process must find expression in the challenge they would take on at the seventh session of the Regional Conference and in Beijing: achievement of real participation in all areas, which was a much-sought-after goal. The principle of solidarity must be consistently observed in all actions: in the political sphere, there was a need to support women who aspired to elective office, including the presidency of their country; the question that needed to be asked was not "Why her, and not me?" but rather "Why him, and not me?", provided the candidate was qualified for the position.

31. She then referred to the progress made, for which the Governments of Latin America and the Caribbean were to be commended, especially with respect to the ratification of the Inter-American Convention on the Prevention, Punishment and Eradication of Violence Against Women. That progress must be built on and translated into real achievements, by inviting all the Governments to seek agreement on women's issues, which were of fundamental importance. As a result, in the development sphere, women should be regarded as being in a key position, given their extraordinary participation in the economic development of peoples. It was also necessary to keep on striving to achieve consensuses between Governments and civil society, and the non-governmental organizations were to be commended for their contribution to that task. Lastly, she said that although the struggle had been a long one it was now beginning to achieve results. It was therefore important to remain optimistic, to avoid becoming despondent, to strike a balance and to overcome differences of opinion.

32. The Chief of the Women and Development Unit, having expressed gratitude to the host country, said that the secretariat had set itself the objective of evaluating actions and producing a comprehensive assessment that would serve as a basis for the formulation of public policies targeting women. The activities carried out at the subregional level had been strengthened, especially in the Caribbean, and the secretariat was interested in supporting the development of government agencies responsible for women's issues. A further sign of progress was the real improvement in relations between Governments and non-governmental organizations. Such organizations were now participating in Government-level meetings, and a new forum for mutual support and joint activities rather than confrontation had been created. In conclusion, she referred to the meeting to be held in November 1994 at ECLAC headquarters in Santiago, Chile, to consider the Regional Programme of Action for the Women of Latin America and the Caribbean, 1995-2001, particularly the strategic actions that formed part of the Regional Programme of Action that had been adopted on a provisional basis, in the light of new inputs received during the sixth session of the Conference.

33. In her statement, the Chairperson of the Presiding Officers said that the Government of Argentina was gratified at the efforts undertaken and the high technical level of the Conference, which had been a landmark event. In that regard, the national reports had been characterized by the wealth of detail provided and their quality; also noteworthy was the participation of the delegations and the specialized agencies of the United Nations system, together with the open and positive attitude of the non-governmental organizations. The work had been intense, and through negotiations broad consensuses had been reached, positions had been reconciled and ways of formulating the Regional Programme of Action had been found. Women had grown in their constructive spirit, and that was reflected in their proposals and objectives. The discussions had shown that change had already begun, and that women's issues were taking on a different emphasis. The Beijing Conference —which would be the last such conference to be held before the turn of the century— would therefore need to be both of great importance and universal in scope. In conclusion, she called on young women to join the endeavour so as to ensure that the twenty-first century would be one of full equality and participation, the women's century, for which preparations would be made in Beijing.

B. SUMMARY OF DEBATES

Report of the Chairperson of the Presiding Officers of the Regional Conference on the Integration of Women into the Economic and Social Development of Latin America and the Caribbean on the work accomplished since the fifth session of the Regional Conference (agenda item 3)

34. Only one statement was made under this agenda item. The Chairperson of the Presiding Officers of the Regional Conference on the Integration of Women into the Economic and Social Development of Latin America and the Caribbean at its fifth session presented a full report on the activities carried out, and drew attention to the important and effective work done by the Presiding Officers. She emphasized in particular that the Presiding Officers had met the goal of submitting to the Conference at its sixth session a draft Regional Programme of Action to update the operational framework of Governments with regard to the issue of women, with a view to achieving the goals of the Platform for Action to be discussed at the Fourth World Conference on Women and to meeting future needs. She placed special emphasis on the efforts made to include in an appropriate manner the views of the Caribbean and the other subregions in the Regional Programme of Action. She also underlined the attention paid to the issue of women in relation to human resources development.

Presentation, by the Secretary-General of the Fourth World Conference on Women, of the Platform for Action to be discussed at Beijing, and preparations for that Conference (agenda item 4)

35. The Secretary-General of the Fourth World Conference on Women, the representative of the People's Republic of China (the host country for that Conference) and the Convenor of the NGO Forum on Women - Beijing '95 made statements on agenda item 4.

36. The Secretary-General emphasized the importance of the work being done at the national level in elaborating documents and carrying out other preparatory activities, since the issues of the Beijing Conference should reflect the countries' specific characteristics and demands. She also stressed the need to reconcile different points of view and to take advantage of the experience acquired in previous international forums, in the spirit of contributing to women's empowerment. It was important to seek a holistic approach that took women of all ages into account; in that regard, the lack of statistical and analytical information on young women and their problems had prompted the secretariat of the World Conference to establish a specific programme on the subject. Lastly, she highlighted the progress made as a result of women's solidarity, the efforts of non-governmental organizations and collaboration between the United Nations Secretariat and the Member States, but also pointed out that future activities in that area would hinge on issues that had not yet been resolved, such as institutionalization and financing.

37. The representative of the People's Republic of China, the host country for the Fourth World Conference on Women, reported on the work done in preparation for that Conference, which had culminated in the signing of an agreement between her country and the United Nations. After describing the facilities in which the activities would take place, the services to be provided to the delegations and the efforts made to publicize the event, she noted the enthusiasm with which her country was collaborating with the United Nations in that area and its willingness to cooperate closely with the Latin American and Caribbean countries that would participate in the Conference.

Report of the ECLAC secretariat on the activities carried out in 1991-1994 and the documentation prepared for consideration at the Conference (agenda item 5)

38. The Convenor of the NGO Forum on Women gave an outline of the preparations for the Forum and emphasized the increasingly extensive preparations under way at the non-governmental level in the various regions.

39. The Deputy Secretary of ECLAC gave a report on the intense activity of the past three years and said that it showed the importance of regional and international conferences as mobilization mechanisms. After briefly reviewing the documentation submitted by the ECLAC secretariat, she noted that the documents and national reports contained a large pool of information which could be used to begin designing wide-ranging policies and to provide a definitive structure to the regional programme of action. That programme would serve as a framework of regional activities and an expression of the Latin American and Caribbean position at the World Conference in 1995.

Analysis and evaluation of the situation of women in Latin America and the Caribbean in the 1990s (agenda item 6)

40. Statements were made under this item by the delegations of Antigua and Barbuda, Argentina, the Bahamas, Barbados, Belize, Bolivia, Chile, Costa Rica, Cuba, Dominica, Ecuador, El Salvador, Spain, the United States, France, Guatemala, Guyana, Haiti, Honduras, Mexico, Nicaragua, Panama, Paraguay, Peru, the Dominican Republic, Trinidad and Tobago, Uruguay, Venezuela, the Netherlands Antilles, Aruba and Puerto Rico; of the Holy See, as an observer; of the Territories of Anguilla and the Turks and Caicos Islands; of the United Nations Centre for Human Settlements (Habitat), UNFPA, WPF, UNDP, UNICEF and UNIFEM; of FAO, UNIDO and UNESCO; of IDB, IACW, IICA, FLACSO, IOM and the Latin American Parliament; of the NGO Forum on Women-Beijing '95, the coordinator of the forum of non-governmental organizations of Latin America and the Caribbean and the coordinator of non-governmental organizations of the Caribbean, in addition to a large number of non-governmental organizations listed in a separate paragraph.

41. Many delegations expressed the view that considerable progress had been made with regard to the situation of women, particularly in terms of public awareness of the issue of gender and rejection of open forms of discrimination. Emphasis was placed on the need to consolidate what had been achieved so far, and some delegations described specific aspects of the progress made in their countries.

42. They were also of the view, however, that much remained to be done in order to achieve equality of women and men. Reference was made, among other needs, to greater access for women, first and foremost, to political power, but also in such other areas as business and the trade unions; the incorporation of the gender perspective into public policies; more effective exercise of democracy at the family, social and State levels; consistency between the international norms incorporated into countries' constitutions with a view to establishing equality and the secondary legislation required for their full implementation; the improvement of education and vocational training; access for women to occupations at a higher level, including occupations in industry; greater visibility of female labour in the area of indicators and statistics disaggregated by sex; the full exercise by groups subject to discrimination, including women, of their rights as citizens; the reformulation of cultural patterns and the way women are depicted in teaching materials and the media; access for women to information; examination in greater depth of the relationship between the issue of women and the environment and such other issues as health (a number of references were made to the AIDS problem), sexual exploitation, sexual harassment and violence against women. It was emphasized that violence against women was a problem that concerned society as a whole, not just women.

43. Several delegations stressed the need to redress the situation of poverty in which a large proportion of the Latin American and Caribbean population lived, which had been found to affect women more severely. In that regard, they made special mention of the situation of rural women and of the need to promote equality of opportunity for those women in terms of access to land, training and credit. They also referred to other groups of women whose situation put them at a disadvantage, such as migrants and other uprooted women, teenage mothers and disabled women.

44. The Caribbean delegations drew particular attention to the debt problem and to structural adjustment programmes, whose impact had been especially severe in the subregion, and emphasized issues such as women's unwaged work, the problems caused by migration, human rights violations, difficulties regarding governability, domestic violence, sexual exploitation and unmet needs in the health field. The

representative of Haiti said that the difficulties in her country were so extreme that they went beyond the parameters of the situation in the rest of Latin America and the Caribbean.

45. A number of delegations said that it was necessary to rethink and reformulate the development model prevailing in the region, taking into account the sweeping changes that had occurred throughout the world and highlighting the subject of sustainable human and social development, which included gender equity and women's full exercise of citizenship as active participants in social processes. It was also important to recognize and appreciate diversity within each society and among women themselves, bringing new social actors into play: not only women, but also young people and indigenous people.

46. The participants also discussed the need to strengthen State institutional mechanisms to ensure that issues concerning women were addressed with responsibility and leadership and to improve coordination among existing entities that dealt with those issues. They also expressed concern about the need for suitable ways of financing activities for the advancement of women. Non-governmental organizations played an essential role in ensuring women's full exercise of their rights as citizens.

47. Also under agenda item 6, some delegations referred to the status of representatives of non-independent territories in international forums, and presented a draft resolution with a view to ensuring greater participation by those representatives in the preparatory activities for the fourth World Conference.

48. The Coordinator of the NGO Forum for Latin America and the Caribbean, which had been held at Mar del Plata from 19 to 23 September, outlined the results of the Forum. She referred to the broad and active participation of national, subregional and regional organizations and to the achievement of major consensuses. Many non-governmental organizations —FEDEFAM, CLACSO, Commonwealth Medical Association, IACW, World Council of Indigenous Peoples, World Union of Catholic Women's Organizations, CODEHUCA, WAGGGS, Socialist International Women, Iniciativa Indígena por la Paz, CAFRA, CELAM, NGO Forum on Women-Beijing '95, Amnesty International, FIMU, CLADEM, Caribbean Youth Organization, Disabled People's International— made statements at the meeting. In addition to discussing the points mentioned by the other delegations, they emphasized the concerns of civil society regarding issues such as respect for human rights, with emphasis on political violence and the suffering it caused, and the impunity of political offences; ethnic discrimination; discrimination against disabled people; general and reproductive health; defending the right to life in a context of responsibility; and developing and ensuring access to education for girls and young women.

Elaboration and adoption of the Regional Programme of Action for the Women of Latin America and the Caribbean, 1995-2001 (agenda item 7)

49. The countries members of ECLAC discussed and adopted the Regional Programme of Action for the Women of Latin America and the Caribbean, 1995-2001, which comprised eight strategic areas: gender equity; economic and social development with a gender perspective: women's equitable share in the decisions, responsibilities and benefits of development; elimination of poverty; women's equitable participation in decision-making and in the exercise of power in public and private life; human rights, peace and violence; shared family responsibilities; recognition of cultural plurality in the region; and international support and cooperation. The text of the Programme is set out in document LC/L.868(MDM.20/2).

50. The Programme was adopted by consensus. The strategic actions it included were adopted provisionally, on the understanding that they would be supplemented with the new proposals submitted by Governments during the current session of the Regional Conference.

51. The participants agreed that the secretariat should submit the final list of those action proposals for consideration at the meeting of the Presiding Officers to be held at ECLAC headquarters in Santiago, which was open to all countries that wished to participate. The list would have been sent to all the countries members of the Commission prior to that meeting.

52. That process would be completed far enough in advance to ensure that the proposals could be taken into account in the elaboration of the Platform for Action of the World Conference.

53. Several countries entered reservations with respect to some paragraphs of the Programme as adopted. The United States delegation entered a reservation with respect to paragraph 4 (Background) and Paragraph 70 (strategic guideline III). The delegations of Argentina, Ecuador and Guatemala entered reservations with respect to paragraphs 63 and 64 (strategic actions II.5.b and c). In that connection, the Argentine delegation stated that it accepted the concept of reproductive rights as expressed in article 16 of the Convention on the Elimination of All Forms of Discrimination against Women, and in paragraph 41 of the Vienna Declaration and Programme of Action adopted by the World Conference on Human Rights (Vienna, 1993). In addition, the Ecuadorian delegation entered a reservation with respect to paragraphs 105 h) and 117 a).

Regional preparations for the Fourth World Conference on Women (agenda item 8)

54. The subject of regional preparations was discussed by a number of delegations, listed at the beginning of the summary of debates on agenda item 6. The representative of Brazil referred more explicitly to regional expectations regarding the World Conference, as did the representative of UNFPA.

55. Emphasis was placed on the relation between the Fourth World Conference on Women and the other United Nations conferences and summit meetings held in the 1990s (on topics such as children, sustainable development and human rights). In that context, the International Conference on Population and Development, held recently at Cairo, would greatly contribute to the World Conference, since it had very constructively established the key role of women's empowerment in the area of population.

56. The delegations reported on the activities carried out at the national and subregional levels to prepare for the sixth session of the Regional Conference and the Fourth World Conference, referring to the national reports submitted to the ECLAC secretariat and to the activities of their respective Governments for the advancement of women.

57. For its part, the ECLAC secretariat reported on the activities envisioned for the Fourth World Conference on Women, which would comprise the following: the preparation of the final version of the Regional Programme of Action, the final review of national reports and the preparation, on the basis of those reports, of a consolidated, updated report for submission to the Beijing Conference. Plans had been made for the preparation of a publication jointly with the rest of the United Nations system that would include both the inputs made and the reference documents submitted at the sixth session of the Conference.

58. One delegation proposed that a database should be set up with the support of the United Nations, concerning the situation of women in the region. Such a database could be based on the national reports, as well as the documents submitted by non-governmental organizations and other institutions; all the materials in question contained a wealth of information.

59. The secretariat took note of the proposal and drew attention to the fact that such a proposal would need to be dealt with in the prescribed manner, because of the financial implications involved.

Seventh session of the Regional Conference on the Integration of Women into the Economic and Social Development of Latin America and the Caribbean (agenda item 9)

60. The delegations agreed in principle that the seventh session of the Regional Conference on the Integration of Women into the Economic and Social Development of Latin America and the Caribbean should be held at ECLAC headquarters in Santiago, Chile, unless a country offered within a reasonable period of time to host the Conference.

Other matters (agenda item 10)

61. No other matters were raised by delegations.

C. RESOLUTIONS

62. The sixth session of the Regional Conference on the Integration of Women into the Economic and Social Development of Latin America and the Caribbean adopted one resolution concerning the Regional Programme of Action for the Women of Latin America and the Caribbean, 1995-2001, and another concerning the participation of associate members of regional economic commissions as observers in future world conferences organized by the United Nations.

**REGIONAL PROGRAMME OF ACTION FOR THE WOMEN OF
LATIN AMERICA AND THE CARIBBEAN, 1995-2001**

The Regional Conference on the Integration of Women into the Economic and Social Development of Latin America and the Caribbean,

Endorsing the content of the Regional Plan of Action for the Integration of Women into Latin American Economic and Social Development (Havana, 1977); the Nairobi Forward-looking Strategies for the Advancement of Women (Nairobi, 1985); the Convention on the Elimination of All Forms of Discrimination against Women; and the resolutions on women adopted since 1985 by the Economic and Social Council and the General Assembly,

Taking into account resolution No. 1 on a new regional plan of action, adopted at the fifth session of the Regional Conference on the Integration of Women into the Economic and Social Development of Latin America and the Caribbean (Curaçao, 1991),*

Also taking into account the recommendations formulated at the meetings of the Presiding Officers elected at the fifth session of the Regional Conference,

Considering the new proposals of ECLAC contained in the resolutions adopted by its member countries for the 1990s, which express the need to take an integrated approach to development in order to achieve the objectives of changing production patterns with social equity, including gender equity,

On the understanding that the new Regional Programme of Action does not replace any of the instruments already in force, but rather seeks to complement them by reflecting the changes observed in the region and their impact on women and by setting forth a basic package of priority activities for Latin America and the Caribbean that can be carried out in the next five years,

Recommends the adoption of the new Regional Programme of Action for the Women of Latin America and the Caribbean, 1995-2001.**

PARTICIPATION OF ASSOCIATE MEMBERS OF REGIONAL ECONOMIC COMMISSIONS AS OBSERVERS IN FUTURE WORLD CONFERENCES ORGANIZED BY THE UNITED NATIONS

The Regional Conference on the Integration of Women into the Economic and Social Development of Latin America and the Caribbean,

Recalling Economic Commission for Latin America and the Caribbean resolution 543(XXV) of 27 April 1994, which, inter alia, requests member countries of the Commission to seek the incorporation into the relevant rules of procedure of provisions granting observer status to associate members of regional economic commissions at future United Nations world conferences, including the Fourth World Conference on Women,

Also recalling the recommendations of the report of the 1994 Caribbean Subregional Meeting Preparatory to the Fourth World Conference on Women, organized by the Economic Commission for Latin America and the Caribbean, the Caribbean Community and the United Nations Development Fund for Women, in support of ongoing measures to ensure that associate members of the Commission are invited to participate in the Fourth World Conference on Women and the global preparatory process of the Commission on the Status of Women,

Taking into account the Caribbean Development and Cooperation Committee resolution of 29 July 1994 in favour of the above initiatives,

Bearing in mind the relevant provisions of the rules of procedure of the United Nations Conference on Environment and Development, the Global Conference on the Sustainable Development of Small Island Developing States, the United Nations Conference on Straddling Fish Stocks and Highly Migratory Fish Stocks, the World Conference on Natural Disaster Reduction and the International Conference on Population and Development providing for the participation of associate members of regional economic commissions as observers,

Endorses the above-mentioned resolutions and recommendations,

Calls on the Commission on the Status of Women, as the relevant preparatory body of the Fourth World Conference on Women, to amend the draft provisional rules of procedure to provide for the participation of associate members of regional economic commissions as observers.
