## ECLAC panel discussion explores innovative financing solutions for the Caribbean

DEPUTY Executive Secretary Antonio Prado moderated the panel discussion entitled "Advocating innovative financing solutions" at the Forum on the Future of the Caribbean on May 7 2015. The session, which examined opportunities that exist for domestic and international development financing for Caribbean Small Island Developing States (SIDS), was considered especially timely given the upcoming United Nations Conference on Financing for Development being held in Addis Ababa in July.

Mr. Prado outlined important areas of focus for countries of the region, the first being the need to address the issue of debt relief in a sustainable manner. He also identified the possibility of mobilizing resources through diaspora bond issue and increased remittances as being worthy of note.

The panel addressed the dilemma of the Caribbean's middle income status and its impact on access to concessional financing. Panelists reiterated the need to look beyond income per capita to States' ability to mobilize finances, debt ratios, vulnerability to shocks and social challenges in determining eligibility for concessional funding.

In closing, Mr. Prado indicated ongoing ECLAC initiatives in the subregion, including pursuit of advocacy for a broader set of criteria to take account of the vulnerability of SIDS; design of a strategy to pursue debt reduction and improve fismanagement in Caribbean states; and expansion of its capacity development efforts towards enhancing resilience building and risk reduction, in order to improve the response to losses from external events and advocate for more secure access to international finance to address this challenge.

Mr. Prado also spoke at the opening of the Forum, signalling that if the Caribbean is to achieve equitable growth in an environmentally sustainable manner, critical challenges will have to be addressed, the most urgent of these being the high and unsustainable levels of public debt. He identified the subregion as one of the most debt-constrained in the world.

Noting that the countries of Latin America and the Caribbean are at a crossroads in terms of their future growth and distribution capacity, he suggested that productivity gains, including product diversification will be needed.

The Forum, under theme "Disruptive Thinking. Bold Action. Practical Outcomes", provided the opportunity for regional and international leaders to tackle challenges to Caribbean development, and identify strategies for securing a sustainable future.

It was co-hosted by The University of the West Indies (UWI), St Augustine, the Ministry of Foreign Affairs of Trinidad and Tobago in collaboration with the United Nations system and other partners.

# **ECLAC Study on Foreign Direct Investment puts focus on the Caribbean**

THE Caribbean receives higher amounts of Foreign Direct Investment (FDI) when compared to other developing economies, according to a newly published report from the Economic Commission for Latin America and the Caribbean (ECLAC).

Entitled "Foreign Direct Investment in Latin America and the Caribbean", the flagship report was launched by ECLAC Executive Secretary, Alicia Bárcena, on 27 May at the organization's headquarters in Santiago, Chile.

For the first time, the flagship report dedicates an entire chapter to foreign direct investment (FDI) in the Caribbean, thus placing increased emphasis on the importance of FDI for the region. FDI inflows into the Caribbean amounted to approximately five per cent of GDP in 2014, compared to three per cent for Latin America, and less in other developing regions.

In the Caribbean, FDI is

important both as a source of funds inflows or possess potential for infor development and as a source of creased FDI. Examples include tourforeign exchange. Nevertheless, questions remain about the extent to which these flows contribute to growth and development in the Caribbean.

Given the increasing propensity of many large Caribbean transnationals to make significant crossborder investments, the report looks at outward FDI from Caribbean countries to regional and extraregional economies.

The publication discusses recent developments in key sectors, which either attract the most FDI

ism, natural resources, manufacturing, business process outsourcing, financial services, and offshore education. Potential benefits and drawbacks of FDI are examined.

The report provides analysis of the modalities commonly utilized by Latin American and Caribbean countries to attract and leverage FDI. It also looks at the extent to which these methods attract FDI. which contributes to economic growth and sustainable development.

# Regional maritime passenger transportation system discussed at ECLAC meeting

THE Economic Commission for Latin America and the Caribbean (ECLAC) recently engaged regional experts in discussions regarding the development of an inter-regional maritime passenger transportation system, which will encourage the maximum utilization of the region's ample available maritime resource.

The Caribbean embraces large maritime space, yet this resource remains vastly under-utilized. Opportunities exist for it to be developed for economic and other benefits for the region.

The possibilities for developing a regional maritime transport system were addressed at a recent meeting at ECLAC's subregional headquar-

ters for the Caribbean in Port of Spain, Trinidad and Tobago.

The meeting brought together representatives of port authorities, ferry operators, maritime consultants, economists and development partners, to consider a demand model for maritime passenger transportation in the Carib-

It was intended to promote regional integration by facilitating movement of persons using the available maritime resource, and also to explore the efficiency and costeffectiveness of maritime passenger transport.

To this end, ECLAC's study entitled "Towards a demand model for maritime passenger transportation in the Caribbean" was be presented for discussion. While there have been numerous studies about cargo transport. and movement of goods and people coming into the region, this study is unique in that it concentrates on the movement of persons within the region.



# Haiti making preparations for CARIFESTA XII

HAITI is preparing to host thousands of people from the region and the world who will converge there for CARIF-ESTA XII.

June 2015

The festival of arts and culture runs from August 21 to 30 and will feature events across the country.

CARIFESTA, which is the largest cultural and artistic event in the Caribbean, has fused all forms of expression of Latin America and the Caribbean since 1972. It has become a

major multicultural and international event that increasingly attracts countries from other continents.

The festival celebrates both diversity and similarity; talent and brotherhood. It gives artistes the opportunity to discuss, share experiences, and learn from one another and to the people of the Caribbean, Latin America and the world the opportunity to share their knowledge and traditions.

Activities will be held in five

cities across Haiti: Port-au-Prince, Jacmel, Cap-Haitien, Gonaives, and Cayes. All disciplines will be featured: dance, cuisine, fashion, cinema, visual arts, literature, music, theatre, arts and crafts.

For visitors, the Haitian government has sought to broker agreements with hotels for special packages and attractive rates for the CARIF-ESTA season.

## LIAT to cut staff

REGIONAL airline LIAT has signaled that it is now ready to reduce its workforce. According to media reports, eligible employees are being asked to apply for voluntary separation or early retirement packages to avoid being made redundant.

The company said this is in keeping with an earlier promise to make LIAT a smaller airline in 2015. In November of last year CEO David Evans had indicated that job cuts were a distinct possibility.

There was subsequent media speculation that some 20 percent of the 600 to 800 workers employed by LIAT



could lose their jobs. Antigua and Barbuda Prime Minister Gaston Browne was also quoted by Observer Radio later as calling for the airline to put on hold plans to axe 180 workers.

According to the latest developments, it would appear that LIAT wants to avoid compulsory redundan-

cies.

LIAT is reported to have warned that insufficient volunteers for voluntary separation or early retirement packages will lead to compulsory redundancies.

The company said downsizing is the only way the carrier can ensure its survival. According to LIAT, its operating schedule for 2015 will be based on eight ATRs flying, with a ninth providing back up support. The airline expects its entire Dash 8 fleet to be removed by the end of this year.

# Grenada opens new consulate in South Florida

GRENADA has opened its first consulate in South Florida. Located in the trendy South Beach area, the new consulate is headed by South African-born Warren Newfield.

Amy Francis, formerly of St Paul's and now the leader of a Grenadian community organisation in South Florida called it the best thing that has happened for Grenadians there in her lifetime.

"We have wanted this for a long time," she said at a community meeting attended by some 100 Grenadians held in the nearby city of Miramar after the official launch in Miami Beach.

The many Grenadians who now live in South Florida cities, such as Miami, Hollywood, Ft Lauderdale, Lauderhill, Miramar, West Park and the Palm Beaches will now be able to access consular services from June 1st.

According to Prime Minister Dr Keith Mitchell, who was there for the launch and the meeting with Grenadians, the office was important as a hub to mobilize investments for Grenada.

"This is the global village and we have to position ourselves in every respect. The only way we can do this is to be able to have this connection in important areas around the global community."
