Forty-eighth meeting of the Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean

Santiago, 7-8 November 2012

ANNOTATED PROVISIONAL AGENDA

I. BACKGROUND

The Regional Conference on Women in Latin America and the Caribbean is a subsidiary body of the Economic Commission for Latin America and the Caribbean (ECLAC) that brings together Government representatives to monitor compliance with international and regional agreements on gender equality.

In consultation with the Government of Brazil, in its capacity as Chair of the Presiding Officers elected at the eleventh session of the Regional Conference on Women in Latin America and the Caribbean, held in Brasilia in July 2010, the Presiding Officers agreed to hold their forty-eighth meeting in Santiago on 7 and 8 November 2012.

At their forty-eighth meeting, the Presiding Officers will consider the preparations being made for the twelfth session of the Regional Conference on Women in Latin America and the Caribbean, in particular, they will review specific studies that will constitute key inputs for the position paper on economic empowerment and information and communication technologies within the framework of the information society. They will also analyse the progress being made towards mainstreaming the gender perspective in public policy.

II. ANNOTATED AGENDA

2. Report on the outcome of the United Nations Conference on Sustainable Development (Rio+20), the meeting of the ECLAC Ad Hoc Committee on Population and Development and the thirty-fourth session of the Commission

The host countries of the United Nations Conference on Sustainable Development (Rio+20) and the meeting of the ECLAC Ad Hoc Committee on Population and Development will report on the outcome of those meetings.

The representative of Brazil will refer, in particular, to the side event on women and sustainable development, held on 21 June 2012 within the framework of the United Nations Conference on Sustainable Development (Rio+20), organized in fulfilment of agreement 6 of the forty-seventh meeting of the Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean, held in Panama City on 3 and 4 May 2012.

The representative of Brazil, in her capacity as Chair of the Regional Conference on Women in Latin America and the Caribbean will present the report submitted to the delegations at the thirty-fourth session of ECLAC, held in San Salvador from 27 to 31 August 2012. The resolutions adopted by the member States of the Commission at its thirty-fourth session will also be presented.

The representative of the Ministry of Women's Affairs of the Dominican Republic will report on the preparations for the twelfth session of the Regional Conference on Women in Latin America and the Caribbean, which will be held in Santo Domingo from 14 to 18 October 2013.

Representatives of member countries will have the opportunity to comment and offer recommendations on the preparations.

Representatives of bodies of the United Nations system will inform delegations of their role in the organization of the twelfth session of the Regional Conference.

The secretariat will also present a proposed calendar, for the first quarter of 2013, of preparatory meetings for the twelfth session of the Regional Conference on Women in Latin America and the Caribbean in accordance with agreement 19 adopted at the forty-seventh meeting of the Presiding Officers, held in Panama City on 3 and 4 May.

The Presiding Officers will decide on their future activities.
