Resolution of June 10, 1949

THE ECONOMIC COMMISSION FOR LATIN AMERICA:

considering that the Commission at its First Session adopted the Resolution of 25 June 1948, requesting the Executive Secretary to submit a preliminary study of the needs of the Latin American countries for technical and administrative personnel, means and facilities—and their present availability; and also requested him, in addition to such a study which was to be presented to the Second Session, to prepare in due course and submit to the various countries, lists of organizations able to render the necessary technical assistance;

TAKES NOTE of the preliminary study on the needs for technical assistance submitted by the Executive Secretary (E/CN.12/84);

TAKES NOTE of the "Progress Report of the Expert of the International Labour Office on Enquiries Conducted into Vocational and Technical Training Requirements and Facilities in Latin America" (E/CN.12/90), and considers that the International Labour Organization should continue and intensify its cooperation with the Executive Secretary;

TAKES NOTE of the communication (E/CN.12/AC.3/W.5)

/addressed to

addressed to the Commission concerning the decision taken by the Governing Body of the International Labour.

Organization to create within the Organization a Committee for Latin America on manpower, and to authorize the creation of a field office of the International Labour Office in Latin America, designed to implement its programme on manpower in the region;

TAKES NOTE of the offer of technical assistance made by the World Health Organization and by the Panamerican Sanitary Bureau;

REQUESTS the executive Secretary to complete, as soon as data from the respective governments become available, the tasks entrusted to him by the Commission in Section (b) of the Resolution of 25 june 1948 and in cooperation with the Governments and with the Organization of American States to continue collecting information and making studies on the needs for technical assistance; and

INVITES the Governments of the Latin American countries to submit as soon as possible a statement of their needs' for technical assistance to the Executive Secretary and to complete those which they may have forwarded already, such statements to be transmitted to the Secretary General in order that they may be considered in carrying out the "Plan for an expanded co-operative programme through the United Nations and the Specialized Agencies";

considering ALSO that in the said Resolution of 25 june 1948 the Commission recognized the important part that technical training and technical assistance play in the economic development of Latin America "for the improved utilization of natural resources and equipment permitting /human effort

human effort to become more productive".

EXPRESSES ITS SATISFACTION with regard to Resolution 200 of the General Asembly on technical assistance for economic development, by virtue of which the Secretary General initiated a programme of services for technical assistance to the Member Governments of the United Nations;

Calls THE ATTENTION of the Latin American Governments to the technical assistance which can now be extended to them by the Sccretary General in accordance with the said Resolution; and especially calls attention (1) to the sending of comprehensive economic missions or groups of experts of the United Nations and the Specialized Agencies to study on the spet possibilities and plans for economic development and (2) to the availability of fellowships for technicians to improve their knowledge and skills abroad;

EXPRESSES ITS SATISFACTION ALSO, with the statement by the President of the United States of America to the effect that the United States in a co-operative enterprise in which all nations work together through the United Nations and its Specialized Agencies, will place at the disposal of the economically under-developed countries the benefits of ther resources of technical knowledge and experience, in order to assist then in raising the standard of living of their peoples;

EXPRESSES THE HOPE that the plan for realizing a broad programme of technical assistance through the United Nations and its Specialized Agencies, which is to be submitted to the Economic and Social Council by the Secretary General in rursuance of the Council's Resolution 180 (VIII), will obtain sufficient support to enable this plan to be

/implemented in

implemented in accordance with the methods and policies which the Economic and Social Council may establish, and thu make possible an effective increase in the technical assistance services of the United Nations and the Specialize Agencies, so that the needs of the Latin American countries may be met;

CALLS THE ATTENTION of the Economic and Social Council to the specific projects requiring technical assistance which have been or may be submitted by the Latin American countries. Some of these projects are mentioned in the Second Part of the Executive Secretary's Preliminary Study on the Needs for Technical Assistance (E/CN.12/84)

REQUESTS the Executive Secretary, in accordance with the methods and policies which the Economic and Social Council of the United Nations may establish, to establish the facilities that will enable him to offer assistance to the Latin American Governments for the appraisal of their most urgent needs for technical assistance foe economic development, acting in co-operation with the Specialized agencies whenever possible.
