REPORT ON THE NATIONAL TRAINING WORKSHOP IN THE ECLAC METHODOLOGY FOR ESTIMATING THE SOCIO-ECONOMIC AND ENVIRONMENTAL EFFECTS OF DISASTERS

The Economic Commission for Latin America and the Caribbean (ECLAC), in collaboration with the United Nations Development Programme (UNDP) and the Cabinet Policy Coordination Unit of the Government of the Cayman Islands, conducted a three-day training course in the methodology to assess sectoral, social, environmental and macroeconomic impacts of natural disasters. The training course was held in Georgetown, Grand Cayman, from 19-20 April 2005.

In 2004, ECLAC in collaboration with UNDP conducted an assessment¹ on the macroeconomic, social and environmental consequences of the tragic and devastating impact of Hurricane Ivan on the Cayman Islands.

Following the assessment, the Government of the Cayman Islands and UNDP entered into an agreement to increase the capacity of the Cayman Islands Government to manage the disaster cycle, with particular reference to risk reduction and management of the rehabilitation process. Within this framework, ECLAC was requested to conduct a training course in its assessment methodology.

The main objective of this training was to expose a wide range of key personnel to the ECLAC methodology, the fundamental concepts that underlie the ECLAC approach; sectoral applications of the methodology; and estimating the impact of a disaster on the main macroeconomic parameters.

ECLAC staff, which included Mr. Erik Blommestein, Ms. Asha Kambon and Mr. Esteban Perez and one UNDP consultant, Mr. David Smith, conducted the training. The course proceeded along the appended agenda and included power point presentations as well as a case study. Mr. Franklin McDonald, UNDP consultant on a hurricane season preparation mission, kindly agreed to make a presentation on vulnerability reduction.

Thirty-one participants attended the workshop. However, many of the participants only attended those sessions that were of direct relevance to their day-to-day work. In consequence only nine persons participated in the case study and returned the questionnaire. A list of participants appears at Annex 2.

Question 1: Specify your area of expertise.

Participants were drawn from a wide range of disciplines and included management, small business and human resource development, engineering, planning, environmental management, disaster preparedness and shelter management, surveying and policy development.

Most participants wanted to better appreciate the ECLAC methodology particularly with a view to understanding how the information of the Cayman Islands Assessment report was derived.

Those who stated a need for further training identified a more detailed application of the ECLAC methodology to the social sector (one participant) and more examples of analysis of data and the use of that data for the future planning of risk management and assigning values.

Question 8: Did the logistics (venue, administrative and technical support) enrich the training, distract from the training or were adequate?

All participants expressed satisfaction with the venue. All, but one, participant found the logistics adequate or better. One participant expressed a concern about limited communication regarding the purpose of the workshop and on the expectations for the future use of the knowledge gained.

Question 9: General comments

Six participants submitted general comments on the workshop. The workshop was seen as necessary for preparation for the next hurricane season and also showed the importance of a systematic data collection practice. With respect to the course itself, it was suggested that instead of the full-blown case study a detailed step by step exercise going through the calculations and assumptions for a particular sector might have been more useful. Another suggestion was that it should be a prerequisite for the participants to study a past ECLAC disaster assessment report to get a better feel for how the information came together.
