


## FOREWORD

This document updates the previous publication, "Major Statistical Publications - Abstracts", (CEPAL/CARIB 83/1) and brings to the researcher a logical first contact with the ECLAC/CDCC statistical database which stores a subset of all the tables published. Through the use of this document, the researcher can be guided to the name of the statistical publication that he or she should access in order to conduct research into the subject matter of interest. The document describes, in addition to the publication, the holdings of the Caribbean Documentation Centre and allows the reader to base subsequent requests for statistics on the indicated holdings of the Caribbean Documentation Centre.

The present document is intended to be the catalyst for statisticians to embark on similar inventories and abstracts in an effort to maximize their understanding of statistical data production in the Caribbean. ## **MAJOR STATISTICAL PUBLICATIONS - ABSTRACTS**

This publication addresses the need to provide information about data sources at the national level in the CDCC countries. It therefore excludes publications of regional or international agencies. This document is designed to throw light on the national activities and reveals the result of statistical activity at the national level which includes departments and government agencies outside the statistical office. Care has been taken to select the most significant and authoritative statistical publications in an attempt to guide the researcher to the most reliable data sets. The major statistical publications are distinguished by the rigour with which data preparation has been undertaken and by the extent to which some attempt has been made to qualify the numbers when such qualification becomes necessary. The document includes both serial and occasional publications as long as they are deemed "major". It does not exclude publications that have ceased to appear. These references continue to be a valuable source of information to researchers and help to fill what would be data gaps in series if they were not referenced.

Although attempts are being made to reach and maintain high standards, the level of excellence is not uniform throughout the statistics-producing agencies. There is still need for a strengthening of the quality of a number of these data recording and disseminating facilities through the mechanism of a Statistical Office performing a leadership function in integrating national statistics. The adoption of common concepts and methodologies will ensure a database that is more consistent and additive than what obtains at present and foster better decisions made through the use of a superior database.

The present document is one component of the meta-data system that must support the core data stored. Its usefulness to the researcher or database planner is readily recognized through the directory function that it performs and through the search capability it offers prior to a move to retrieve data. Problems of receipt of publications from countries and difficulties of processing the incoming documents have led to a weakening of the ability to report on holdings of the Caribbean Documentation Centre.

### Design of the records:

The records as presented in this document have been constructed from the holdings of documents lodged in the Caribbean Documentation Centre. Over time, document names have changed and there has been movement in and out of existence of reports. The records report on the names of the documents as they appear and present information of interest to the researcher. The design is as follows:

The Publisher information can present problems of tracing over time as Ministry names undergo change in accordance with government reorganizations. In addition, agency names may change in order to reflect growth or some change in orientation. To the extent possible, the new name may be added in parentheses to reflect the change.

The Document Name may present problems of discontinuity over time, as indeed some documents may go out of existence while new ones appear, carrying the major part of the content of the former document.

Very few titles included in this document have standardized classification numbers such as the ISSN or ISBN codes. Publishers of documents are encouraged to seek the assistance of their documentalists colleagues to be informed of the desirability of acquiring such document numbers. Frequency in the publication of reports has, in the past, been affected by the several national financial crises and the consequent curtailment of government spending. Whereas in most cases no formal crossover to a different periodicity has been made, the documents lag in terms of delivery and several issues never reach the printer. Accommodations have been made by producing one publication that bridges the gap that would have been filled by more than one publication, thereby making difficult the ability to describe the holdings of the serial publication.

The holdings are therefore the softest area covered by the records in the present document. The constructors of the data base have nevertheless proceeded to present the information in the hope that it would be used as an indication of the data coverage that may be resident in the Caribbean Documentation Centre. Ultimately, the producing agency will be able to fill in the gaps that occur in the holdings to the extent that these gaps were in fact filled. The Statistics Unit views this publication as both an information offering as well as a mechanism for the cleaning of the data set disseminated. Feedback from the national data-producing units will be relied on to improve the document.

The abstracts contain a short description of the contents of the documents. They indicate the type of information that can be obtained from the documents and are in fact a first point of contact between the researcher and the database.

A set of descriptors has been included in the database for use in searching the documents with greater specificity. Care has been taken to capture the subject matter included in the documents. For this purpose the descriptors have been prepared and can be used, though not presented in this document.

It is hoped that this document will be refined through the scrutiny and bibliographic work of the countries and agencies whose documents are described in this document. In this regard the ECLAC/CDCC secretariat urges the national entities, whose work is reflected in this document, to actively edit the contents and provide the updated information so that a more accurate and useful information document can be produced to the benefit of all researchers.
