STATEMENT BY THE EXECUTIVE SECRETARY^{2/}

Mr. PREBISCH (Executive Secretary) described some of the principal economic problems facing the Latin American countries, and suggested possible solutions.

Special attention should, in his view, be given to questions of the balanced development of industry and agriculture, capital investment and inflation.

He reviewed ECLA's recent work in connexion with the possible establishment of a multilateral payments system and a common regional market.
