Page 7: Paragraph 3. ~~At~~ the following sentence at the end of the paragraph: "and to Section 05 - Industrial development."

Page 10: Projects discontinued, dropped or postponed  
Remove project 00-12, Financing of development, and the corresponding text in the end column from this section.

Page 13: After project 00-111, insert  
"00-12 Financing of development ECLA 226 (X) and  
228 (X)"

Change the numbers of the three succeeding projects to 00-13, 00-14 and 00-15, and delete the asterisks.

Page 14: Delete the six last words on the page.

Page 15: Paragraph 1. Delete the entire paragraph. Replace by the following text:

"a second stage was completed with the publication, in March 1967, of a broader study and research on the subject will continue during 1967-68, when new analyses will be included on income distribution in relation to Latin American development. In addition, research in greater depth will be undertaken on income distribution policies, in preparation for a working group (00-111) scheduled to take place at the end of 1968."

"Research on financing of development (00-12) will be undertaken on a joint basis with IDB and consultations on this are in progress."

Page 19: Projects completed. After 01-312, insert the following projects:

"01-313 The structural nature of the rural housing problem in Latin America id. A paper on this subject was prepared for the Inter-Regional Seminar on Rural Housing and Community Services (Maracay, Venezuela, 3-20 April 1967)."

Page 28: (Projects completed) Insert at the top of the page the following

project: "02-0 Latin America and ECLA 262 A study with this international trade (AC.58) title was presented at the Commission's twelfth session." policy

Project 02-03: Replace the words "a meeting of government experts scheduled for March 1967" by the following text:

"the twelfth session of the Commission (E/CN.12/774)."

Page 29: Project 02-53. Delete this project from "Projects completed" and

Page 31: After project 02-5, insert the above project, as follows:

" 02-51\*\* A Meeting of high-level government id. representatives of relatively less developed countries"

Page 36: Projects completed Delete project 04-05 and insert it at the end of the chart on page 39, as follows:

"04-05 A Economic development of ECLA 195 (IX) British Honduras (Belize) 1967"

Page 66 At the end of the section 05-0, insert the following:

"A comparative study is being considered of capital coefficients and other basic relationships for industrial projects financed by development banks and corporations in Latin America; however, it can only be carried out if sufficient support is obtained from financing agencies for industrial development in the region, with which consultations will be undertaken in the next few months. If the funds obtained should prove insufficient, this project could replace either project 05-04 or 05-05.

Page 67: At the end of the section 05-1 add the following:

"Conversations are in progress with the United Nations Department of Economic and Social Affairs and the United Nations Institute for Training and Research (UNITAR) concerning a Headquarters

project on transfer of technology to developing countries through arrangements between enterprises, to which ECLA would contribute any studies on Latin America. If a positive decision is taken on the matter, experts from different sectors of industry, and in particular steelmaking and basic equipment, would collaborate, some of them on a consultant basis financed by additional funds.

Page 68: Project 05-5: after the first paragraph insert the following:  
"A study is also being prepared on the situation in Latin America of rubber production and consumption, for both synthetic and natural rubber, for presentation at the XIX Assembly of the International Rubber Study Group (September 1967)."

Page 101: Add at the end of the chart the following projects:
