THE ECONOMIC COMMISSION FOR LATIN AMERICA,

HAVING CONSIDERED document E/CN.12/234 on Effects of the
United States Defence Programme on Trade with Latin America,

RESOLVES

1. To express its satisfaction with the timeliness and the usefulness of the document as a source of information for Member Governments; and
2. To recommend to the Executive Secretary that, in view of the effect on the economic life of the Continent of phenomena which cause profound changes in the normal course of the activities of the United States of America and important European centres of supply, he should prepare and circulate analyses of the same general nature as document E/CN.12/234.
