ADOPTION OF THE RAPPORTEUR'S REPORT (Conference Room Paper N° 37)

Mr. GOMEZ (Colombia), Rapporteur, read out the draft report on the activities of Committee III which was presented for consideration by the Committee. He explained that for lack of space and time, the observations made in it were necessarily of a general nature.

The CHAIRMAN invited comments on sections 1 and 2 (a) of the draft report.

Mr. DELGADO (Mexico) referred to page 8, third paragraph, and suggested that the words "at their express request" should be inserted after "Governments".

It was so decided.

Mr. GONZALEZ OVIEDO (Paraguay) suggested that, in order to avoid repetition of the word "request", the last line should be changed to read "preparation of applications to the Special Fund in that connexion".

It was so decided.

Mr. DELGADO (Mexico), referring to the same paragraph, said that mention should be made of other international credit agencies apart from the United Nations Special Fund.

Mr. GOMEZ (Colombia), Rapporteur, suggested that the phrase "and to other international credit organizations" should be inserted in the last line of the paragraph after the words "Special Fund".

It was so decided.

Mr. DELGADO (Mexico) expressed his satisfaction with the stress that had been laid on the importance of giving priority to studies on small and medium-scale industry.

The CHAIRMAN invited the representatives to comment on section 2 (b) of the draft report.

Mr. PARELLADA (Argentina) said that the word "on irrigated land" should be inserted in the third paragraph of page 12 after the words "intensive cultivation". He also suggested that the phrase "at low cost, especially after amortization" should be inserted after the words "a substantial volume of electric power" in the fifth paragraph on page 14.

It was so decided.

The draft report was adopted unanimously.

The meeting rose at 1.10 p.m.
