## **A. ATTENDANCE AND ORGANIZATION OF WORK**

### **Place and date of the meeting**

1. The Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean held their sixty-third meeting in Buenos Aires on 8 November 2022.

### **Attendance<sup>1</sup>**

2. The meeting was attended by representatives of the following member countries in their capacity as Presiding Officers: Argentina, Brazil, Chile, Costa Rica, Cuba, Dominican Republic, Ecuador, El Salvador, Mexico, Panama, Paraguay, Peru, Plurinational State of Bolivia and Uruguay.

3. Also attending were representatives of the following member countries of the Economic Commission for Latin America and the Caribbean (ECLAC): Bolivarian Republic of Venezuela, Colombia and Honduras.

5. The Presiding Officers adopted the following agenda:

## **C. SUMMARY OF PROCEEDINGS**

6. The opening session was addressed by José Manuel Salazar-Xirinachs, Executive Secretary of the Economic Commission for Latin America and the Caribbean (ECLAC); María-Noel Vaeza, Regional Director for the Americas and the Caribbean of the United Nations Entity for Gender Equality and the Empowerment of Women (UN-Women); Antonia Orellana, Minister of Women’s Affairs and Gender Equity of Chile, in her capacity as Chair of the Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean; and Ayelén Mazzina, Minister for Women, Gender and Diversity of Argentina and representative of the host country of the fifteenth session of the Regional Conference on Women in Latin America and the Caribbean.

7. The Executive Secretary of ECLAC highlighted the joint work of ECLAC, UN-Women and the Governments of Argentina and Chile in preparing the meeting. He noted that gender equality and the care society, as well as the Commission’s work in those areas, were among the issues to be discussed. He acknowledged the work done by the Government of Chile in its capacity as Chair of the Presiding Offices for the last few years and drew attention to initiatives such as the Regional Alliance for Women’s Digitalization in Latin America and the Caribbean and the establishment of the Regional Fund in support of Women’s and Feminist Organizations and Movements. He underscored the need for bold and transformative proposals that would offer realistic and pragmatic solutions to address the gender inequalities and gaps in the region and stressed that the care society would be the cornerstone for transforming the existing development paradigm.

8. The Regional Director for the Americas and the Caribbean of UN-Women welcomed the holding of an in-person meeting after more than two years of the coronavirus disease (COVID-19) pandemic. She mentioned the side events held in the framework of the fifteenth session of the Conference such as the parliamentary forum, the feminist forum and the youth forum, and underscored their importance. She reported on some of the progress made with regard to funding and projects under way in the Regional Fund in support of Women’s and Feminist Organizations and Movements. She praised the collaboration between UN-Women and ECLAC and spoke of the preparations for the sixty-fourth meeting of the Presiding Officers, which would take place before the sixty-seventh session of the Commission on the Status of Women.

9. The Minister of Women's Affairs and Gender Equity of Chile, in her capacity as Chair of the Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean, said that the pandemic had hindered the implementation of the agenda derived from the fourteenth session of the Regional Conference on Women in Latin America and the Caribbean, held in Santiago in 2020, and which had been set forth in the Santiago Commitment (2020). She noted that the coordinated efforts of the countries of the region had been key to its implementation and that the digital transformation agenda had played a key role in the response to the emergency. She said that against the backdrop of cascading crises, the main challenge for countries was to avoid backsliding on commitments made in the area of care.

10. The Minister for Women, Gender and Diversity of Argentina and representative of the host country of the fifteenth session of the Regional Conference on Women in Latin America and the Caribbean thanked the Government of Chile or its three-year term as Chair of the Presiding Officers and emphasized the importance that spaces such as the Conference offered for listening, sharing, networking, building alliances and working towards a more just society.

Report of the Chair of the Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean (agenda item 2)

11. The Chair of the Presiding Officers reported on the activities carried out since 2020. She recalled that at the fourteenth session of the Conference, countries had adopted the Santiago Commitment, which included agreements on ending gender-based violence, encouraging women's labour participation, reducing pay gaps and increasing women's participation in decision-making, among others. She noted the holding of the sixtieth meeting of the Presiding Officers and the special regional consultation prior to the sixty-fifth session of the Commission on the Status of Women, held in February 2021,<sup>2</sup> and highlighted the approval of the Regional Alliance for Women's Digitalization in Latin America and the Caribbean, which aimed to reduce gender gaps in information and communications technologies and promote the full participation of women in the digital economy.

12. She also recalled that at its sixty-first meeting, held in September 2021, the Presiding Officers had adopted the road map towards the fifteenth session of the Regional Conference on Women in Latin America and the Caribbean and had received a report on the Regional Fund in support of Women's and Feminist Organizations and Movements, whose first call for proposals had received more than 250 submissions, with proposals from 18 women's and feminist organizations from 10 countries of the region selected. A report on progress in the Regional Alliance for Women's Digitalization had also been presented by Chile. The highlights of the sixty-second meeting of the Presiding Officers included the progress made on the road map towards the fifteenth session of the Regional Conference, presentations on the Regional Alliance for Women's Digitalization and the Regional Fund in support of Women's and Feminist Organizations and Movements, the regional consultation prior to the sixty-sixth session of the Commission on the Status of Women, and the adoption of the Declaration by the ministers and high-level authorities of the national machineries for the advancement of women in Latin America and the Caribbean, which reflected the importance of achieving gender equality and the empowerment of all women and girls in the context of climate change, environmental and disaster risk reduction policies and programmes. Lastly, she referred to the special meeting of the Presiding Officers of the Regional Conference held in June 2022, which had continued the work leading up to the fifteenth session of the Conference and had commemorated the forty-fifth anniversary of the Regional Gender Agenda.

Report by the secretariat on the organization of work for the fifteenth session of the Regional Conference on Women in Latin America and the Caribbean (Buenos Aires, 7–11 November 2022) (agenda item 3)

13. The Chief of the Division for Gender Affairs of ECLAC presented the report by the secretariat on the organization of work for the fifteenth session of the Conference, underlining that the Conference was the culmination of a collective and participatory process and that it provided an opportunity to seek bold and innovative solutions in the region, such as the care society.

14. The Secretary of the Commission then spoke on two matters related to the fifteenth session of the Conference: the Chair of the Presiding Officers would be elected at the opening of the fifteenth session, and countries could express their interest in joining the Presiding Officers in the coming days. With regard to the Buenos Aires Commitment, he referred to the process by which the draft agreement had been prepared, under the leadership of the Chair of the Conference, with Chile currently serving in that capacity, and Argentina as the incoming Chair. In that regard, he said that two working sessions would be held with member States to arrive at consensus.

15. In the ensuing discussion, the President of the National Women's Institute of Mexico (INMUJERES) of Mexico, applauding the work done in preparation for the fifteenth session of the Conference, said that Mexico had made significant steps toward gender equality and underlined the need to promote women's representation in leadership positions and their participation in public life. She also expressed her country's interest in hosting the sixteenth session of the Regional Conference on Women in Latin America and the Caribbean.

16. The Vice-Minister for Multilateral Affairs of the Ministry of Foreign Affairs of Colombia thanked ECLAC, Chile and Argentina for their guidance in the preparations for the fifteenth session of the Conference. She said that Colombia was committed to achieving gender equality and expressed her country's interest in hosting the seventeenth session of the Regional Conference on Women in Latin America and the Caribbean.

17. The Executive President of the National Institute for Women (INAMU) of Costa Rica reported on some of the care policies that had been implemented in the country. She said that INAMU played a major role in Costa Rica's institutional framework and mechanisms, and that a governing body for related policies was being promoted. She urged countries to join forces and avoid backsliding so that the region could continue on its path towards gender equality.

18. The Secretary of State in the Office of Women's Affairs of Honduras said that her country was pleased to participate in the fifteenth session of the Conference and expressed her enthusiasm at coming together once again to forge a society that would enable women to reclaim the exercise of their human rights.

### **Closing session**

19. In the closing session, the Minister of Women's Affairs and Gender Equity of Chile thanked ECLAC and UN-Women for their work and expressed the hope that the themes that would be addressed at the fifteenth session of the Conference would provide a blueprint for the future for the whole world. The region could chart the course for economic recovery with equality, sustainability and with care at the centre, as it had already done on other issues, such as violence against women.

20. Lastly, the Minister for Women, Gender and Diversity of Argentina thanked representatives and expressed her hope that the best strategies for achieving the society sought by women, children and adolescents would be put forward at the fifteenth session of Conference, in cooperation with the feminist movement and various organizations, and working alongside men to achieve equality.
