### ANNOTATED PROVISIONAL AGENDA

#### A. BACKGROUND AND OBJECTIVES

The Regional Conference on Women in Latin America and the Caribbean is a subsidiary body of the Economic Commission for Latin America and the Caribbean (ECLAC) that brings together government representatives to monitor compliance with international and regional agreements on gender equality and to promote the incorporation of the gender perspective in regional policies, in order to make progress towards women's autonomy.

Pursuant to the agreement adopted at the fifty-second meeting of the Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean, concerning the initiative by ECLAC and the United Nations Entity for Gender Equality and the Empowerment of Women (UN-Women), the adhoc regional consultation for Latin America and the Caribbean in preparation for the sixtieth session of the Commission on the Status of Women will be held within the framework of the fifty-third meeting of the Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean. The conclusions and recommendations of that consultation will be submitted by the Chair of the Regional Conference to the Commission on the Status of Women at its sixtieth session in March 2016.

The fifty-third meeting of the Presiding Officers will focus on the preparations for the thirteenth session of the Regional Conference on Women in Latin America and the Caribbean and examine the activities conducted since the fifty-second meeting of the Presiding Officers of the Regional Conference on Women. Reports will be given at the meeting on the participation of the secretariat and of national mechanisms for the advancement of women in meetings of interest to the Presiding Officers. The Presiding Officers will also discuss the 2030 Agenda for Sustainable Development and the Sustainable Development Goals and their coordination with the global and regional agenda on gender equality and women's autonomy.

The floor will then be offered to representatives who wish to report on their participation in those meetings and refer to the agreements adopted and their links with gender equality.

The secretariat will present an update on the preparation of the position paper for the thirteenth session of the Regional Conference and will report on the specific studies that are key inputs for the position paper on gender equality, women's autonomy and the 2030 Agenda for Sustainable Development.

The member countries, specialized agencies and other bodies of the United Nations system will then have the opportunity to make comments and recommendations in this connection.

# 6. High-level panel on the 2030 Agenda on Sustainable Development and the Sustainable Development Goals, and their coordination with the regional agenda on gender equality and women's autonomy

The panel will be moderated by the Chair of the Presiding Officers of the Regional Conference on Women in Latin America and the Caribbean and will consist of representatives of international organizations and Latin America and the Caribbean governments.

### 7. Special regional consultation in preparation for the sixtieth session of the Commission on the Status of Women

The sixtieth session of the United Nations Commission on the Status of Women will be held in New York, from 14 to 24 March 2016, with "Women's empowerment and its link to sustainable development" as the priority theme. The Commission is the appropriate forum in which to discuss how to build momentum for implementation of the 2030 Agenda on Sustainable Development and the Sustainable Development Goals, while keeping gender equality and women's autonomy at the centre of discussions.

This special consultation, co-organized by ECLAC and UN-Women, will provide a forum to discuss that priority theme in relation to Latin America and the Caribbean. It will be attended by representatives of governments and civil society from the countries of the region, specialized agencies and other bodies of the United Nations system. It is expected that the conclusions and recommendations adopted at this regional consultation will be submitted by the Ministers and representatives of the national mechanisms for women in the region to the Commission on the Status of Women at its sixtieth session.

A debate will follow each panel discussion. This debate will be open to representatives of member States, after whose statements the floor will be offered to other participants.

The Presiding Officers will consider and adopt the agreements of their fifty-third meeting.
