

FOREWORD

With the increasing use of statistics and information, there is an accompanying need to assess the quality of the information being used as an input in the decision-making process. This information about information is known as "Meta Data" and must be as carefully viewed as the figures themselves. In small countries such as those of the Caribbean, variances between two different data sources which measure the same phenomenon may arise because of differences in the time of computation. They may also occur because of differences in the sources from which the input data were derived. Together with the dissemination of the numbers, the disclosure of sources and some commentary on data quality may help to put "texture" to the data.

This document describes the contents of nationally produced documents that cover a wide variety of statistical series. It lists the publishers of statistics and presents the main documents, providing for each one the ISSN document reference, the periodicity of publication and an abstract of the contents.

This document is a first stop for many researchers who need assistance to find out what exists and where. Its geographical scope will be useful in providing the researcher with a single source of information on Caribbean statistics. It will appear on the ECLAC/CDCC Statistics Homepage on the World Wide Web.

ABSTRACTS

This document addresses the ongoing need to provide information about the data sources at national level in the CDCC countries. It, therefore, excludes publications of regional or international agencies. Through the present document, the reader can gain an appreciation of the nature and scope of the data collection and analysis that take place in the various countries. It is a subset of what should be done at national level. Whereas the scope of this document is confined to "major publications", the statistical offices of the several countries would do well to conduct similar and more exhaustive inventories of information that is processed and published within the nation. It is the first step towards the rationalization of data presented to the public. Often several agencies publish different figures that purport to measure the same phenomenon without adequate prefacing of their work. The result is a confusion in the mind of the user as to which is the "correct" figure. It may well be that both figures are correct in terms of the methodology behind their derivation. Proper prefacing would make these differences clear and put to rest any tendency towards confusion. The preparation of the suggested inventories will lay the groundwork for a discussion of ways and means in which the data collection effort could be streamlined and made more efficient and cost-effective.

The present document should be of special appeal to those who guide the development of the statistical services of their countries. The opportunity that is herein afforded to make country comparisons as regards the quantum and quality of the data collected. The extent to which the statistical apparatus tracks the changes in the external environment can be observed by the extent to which new series are produced. For example, statistics on bankruptcies of firms are now demanded so that an appreciation of the problem can be gained.

An attempt is made to structure the document to be of maximum use to the researcher. The records are structured to present information on the following:

The coding scheme for country accords with the DEVSIS classification that is familiar to documentalists. Its use in this document, therefore, affords a ready assimilation into the work of the library personnel.

The publisher of a given document may change from time to time. This would normally present a problem of recording the change. In the present document an attempt is made to provide

a trail of the changes in publisher as well as document name as these changes take place over time.

Very few titles included in this document have standardized classification numbers, such as the ISSN or ISBN codes. Publishers are encouraged to seek the assistance of the documentalist to acquire these numbers. The document provides information on the periodicity of publication (frequency of the offerings.

The abstract is a short description of the contents of the document. It indicates the type of information that can be obtained from the documents and is in fact a first point of contact between the researcher and the database. The records presented are the combination of the items discussed the Country name, the Publisher, the Document name, the ISSN number, the Frequency and the Abstract. These combine to give the researcher a wealth of information with which to approach the documentalist when seeking information on statistics.

This document has been refined by update provided by the countries. Further vigilance will provide more updates to future versions of the publication. The ECLAC/CDCC secretariat urges the national entities to undertake the inventory exercise and update the present document in the light of their findings.
