ANNOTATED PROVISIONAL AGENDA AND ORGANIZATION OF THE MEETING

# I. ORGANIZATION OF THE TWENTY-SECOND MEETING OF THE PRESIDING OFFICERS

Pursuant to paragraph 88 (2) of the Regional Plan of Action for the Integration of Women into Latin American Economic and Social Development, adopted in 1977 at the eleventh extraordinary session of the Committee of the Whole of the Economic Commission for Latin America and the Caribbean (ECLAC), the Presiding Officers have the responsibility for acting as the link between member Governments and the ECLAC secretariat in the field of women's integration in development. In fulfilment of this provision, the Presiding Officers will hold their twenty-second meeting at ECLAC headquarters in Santiago, Chile, on 16 and 17 May 1996.

Moreover, under section E, paragraph 261 (b), of the Regional Programme of Action for the Women of Latin America and the Caribbean, 1995-2001, adopted by the countries members of ECLAC at the sixth session of the Regional Conference on the Integration of Women into the Economic and Social Development of Latin America and the Caribbean held in Mar del Plata, Argentina, from 25 to 29 September 1994, the Presiding Officers of the Regional Conference are responsible for following up the implementation of the Programme of Action.

The Presiding Officers elected at the sixth session of the Regional Conference, who will serve until the next session of the Conference, are: Argentina (Chairman); Barbados, Bolivia, Chile, Cuba, Ecuador, Honduras, Netherlands Antilles and Uruguay (Vice-Chairmen); and Mexico (Rapporteur).

Debate at the session will revolve around the reform of the United Nations and activities in followup to the Platform for Action adopted at the Fourth World Conference on Women held in Beijing.

Below are the provisional agenda and annotations providing background information on the proposed agenda items.

#### II. ANNOTATED PROVISIONAL AGENDA

1. Adoption of the provisional agenda and organization of the work of the twenty-second meeting of the Presiding Officers

The representatives will have before them, for their consideration and approval, the provisional agenda (LC/L.936 (MDM.22/1)), which has been prepared by the secretariat, bearing in mind the various mandates of the Presiding Officers. The countries serving as Presiding Officers may offer any comments or propose any changes they think desirable.

The Chairman and the delegations attending will report on activities related to the issue that are being carried out in their countries and subregions.

Because of its impact on the work of the ECLAC secretariat, a report will also be given on the results of the fortieth session of the Commission on the Status of Women and their influence on activities on the regional level.

At the twenty-sixth session of ECLAC held in San José, Costa Rica, from 15 to 20 April 1996, the secretariat submitted a note as a contribution to the debate among the member countries, in view of the climate of reform and financial constraint in which the United Nations is now operating. Because these factors will necessarily have an impact on activities relating to women, it was thought advisable to bring this situation to the attention of the delegations, to facilitate their participation in the debates on the matter.
