I N T R O D U C T I O N

The data appearing in this publication represent the best data set as provided by the Member countries and Associate Members of the Caribbean Development and Co-operation Committee (CDCC) by year end 1988. The submissions in this report are the result of a questionnaire which was sent to the Member countries of CDCC and incorporate supplements from the Production Yearbook of the Food and Agricultural Organization (FAO). The need for supplementing the data arose from the very poor response rate that the CDCC questionnaire attracted, since only some 56 percent of the countries solicited in the survey provided returns of varying quality and data content. As a result of this, the questionnaire has been revised with a view to making it more explicit and easy to complete when next the survey is conducted. This document has been redesigned to make effective use of the graph in communicating the movement of indicators. Some parts of the questionnaire were not answered, or were not answered well, and as a result, the tables included a great number of zeros. Particularly weak tables of this nature have been excluded from the present publication.

Areas of great interest in the document include the set of tables on production and the underlying structures of ownership and land use. Information on these areas is not usually up-to-date, making the reported values less than optimally useful. It is hoped that the Governments receiving copies of this document would look into the collection and provision of data with the utmost urgency. The co-operation of the Member and Associate Member countries of the CDCC which furnished the data requested for this publication is gratefully acknowledged.

This publication represents a major step in the redesigning of the presentation of the Agricultural Statistics of the Caribbean. It gives me great pleasure to commend to the researcher the present volume of "Agricultural Statistics".

I N T R O D U C T I O N

Les données présentées dans cette publication constituent le meilleur ensemble des données fournies par les pays Membres et par les Membres Associés du Comité de développement et de coopération des Caraïbes (CDCC) jusqu'à la fin de 1988. Le contenu de ce document repose pour l'essentiel sur les réponses reçues sur un questionnaire distribué aux pays Membres du CDCC mais inclut aussi des suppléments composés de matériel additionnel tiré de l'Annuaire FAO de production. La nécessité d'y apporter ces données supplémentaires résulte du taux de réponses au questionnaire du CDCC extrêmement faible, car seulement 56 pour cent des pays enquêtés ont fourni des réponses, réponses dont la qualité et le contenu étaient, de surcroît, fort variables. Par conséquent, le questionnaire a été révisé pour le rendre plus explicite et plus facile à compléter lors de la prochaine enquête. Le format du document a été réorganisé en vue d'un usage plus efficace du graphique dans la représentation du mouvement des indicateurs. Quelques sections du questionnaire n'ayant pas suscité de réponse, ou n'ayant suscité que des réponses incomplètes, les tables affichaient un nombre considérable de zéros. Les tables les plus défectueuses à cet égard ont été exclues de cette publication.

Parmi les domaines de plus grand intérêt de ce document figure l'ensemble des tables se rapportant à la production et aux structures sous-jacentes du régime foncier et de l'utilisation du sol. L'information disponible sur ces domaines n'est généralement pas à jour, ce qui confère aux valeurs présentées une utilité moins qu'optimale. Il est à espérer que les gouvernements qui recevront des exemplaires de ce document examineront d'extrême urgence leurs systèmes de collecte et de remise de données. La coopération des pays Membres et Membres Associés du CDCC qui ont fourni les données demandées est sincèrement remerciée.

La présente publication représente une avance majeure dans la réorganisation de la présentation des Statistiques agricoles des Caraïbes. J'ai grand plaisir à recommander au chercheur la présente édition de Statistiques Agricoles.

I N T R O D U C C I O N

Los datos presentados en esta publicación constituyen la mejor recopilación posible de los datos proporcionados por los países Miembros y Miembros asociados del Comité de Desarrollo y Cooperación del Caribe (CDCC) para fines del año 1988. El presente informe se compiló en base a un cuestionario que había sido distribuido a los países miembros del CDCC, e incorpora suplementos compuestos de información sacada del Anuario FAO de Producción. La necesidad de suplementar los datos surgió de la limitada tasa de respuesta al cuestionario del CDCC, ya que sólo alrededor de 56 por ciento de los países encuestados sometieron respuestas, cuya calidad y contenido fueron además muy variables. Por ende se ha revisado el cuestionario con el propósito de hacerlo más explícito y más fácil de llenar cuando se lleve a cabo la próxima encuesta. El diseño del presente documento ha sido revisado para lograr un uso más eficaz de gráficas en la representación del movimiento de los indicadores. Algunas secciones del cuestionario no fueron completadas, o se completaron sólo parcialmente, y como resultado los cuadros incluyeron un gran número de ceros. Los cuadros más defectuosos en este respecto han sido excluidos de la presente edición.

Entre las áreas de mayor interés del documento figura el conjunto de cuadros sobre producción y las estructuras subyacentes de tenencia y uso de la tierra. Por regla general, la información disponible sobre estos aspectos no está actualizada, siendo por tanto los valores registrados de reducida utilidad. Se espera que los gobiernos que reciban ejemplares de este documento examinen con la mayor urgencia sus sistemas de recopilación y sumisión de datos. Se agradece sinceramente la cooperación de aquellos países Miembros y Miembros Asociados del CDCC que propiciaron los datos solicitados.

Esta publicación constituye un avance importante en la revisión del formato de presentación de estadísticas agropecuarias de los Países del Caribe. Me da un gran placer recomendar al investigador esta edición de "Estadísticas Agrícolas".

Notes on the Tables

Land Use and Irrigation

Data relate to available information at the end of 1987 and may represent the exact land use and irrigation activities at an earlier date. Definitions of land use categories are as follows:

1. Total area - refers to total area of the country, including area under inland water bodies (major rivers and lakes).
2. Land area - refers to total area of the country, excluding area under inland water bodies.
3. Arable land - refers to land under temporary crops, temporary meadows for mowing or pastures, land under market and kitchen gardens and land temporarily fallow or lying idle.
4. Land under permanent crops - refers to land cultivated with crops that occupy the land for long periods and need not be replanted after each harvest.
5. Permanent meadows and pastures - refers to land used permanently for forage crops, cultivated or growing wild.
6. Forests and woodlands - refers to land under natural or planted stands of trees.
7. Other land - includes unused but potentially productive land, built on areas, wasteland, parks, roads and any other land not specifically listed under items 3 through 6.
8. Data on irrigation relate to areas purposely provided with water, whether this area is irrigated several times or only once during the year stated.

Table 9 summarises the results of the most recent agricultural census in the Eastern Caribbean countries, Commonwealth of the Bahamas, Belize and the Republic of Suriname.

Population

Table 2 presents estimates of total population, agricultural population and economically active population, total and in agriculture.

These data are generally provided by the countries.

Data relate generally to the present-in-area (de facto) population within the present geographical boundaries.

Agricultural population is defined as all persons depending for their livelihood on agriculture.

Economically active population is defined as all persons engaged or seeking employment in an economic activity.

Economically active population in agriculture includes all economically active persons engaged principally in agriculture, forestry, hunting or fishing.

Gross Domestic Product

The high instability recorded for exchange rates and inflationary trends in some of the Member countries of the CDCC during the last decade, precludes the presentation of the information on GDP in one single currency as in previous issues. Therefore, the related tables show, as up-to-date as possible, data in current national currencies.

Notes concernant les tableaux

Utilisation des terres et irrigation

Les données concernant les informations disponibles à la fin de l'année 1987 représentent forcément les activités antérieures en matière d'utilisation des terres et d'irrigation. Les catégories de terres sont définies comme suit:

1. Superficie totale - celle du pays, y compris les eaux intérieures (principaux cours d'eau et lacs).
2. Superficie des terres - celle du pays moins la superficie des eaux intérieures.
3. Terres arables - terres affectées aux cultures, temporaires, ou non, prairies temporaires, faucher ou à pâturer, jardins maraichers ou potagers et terres en jachères temporaires ou incultes.
4. Cultures permanentes - cultures qui occupent le terrain pendant de longues périodes et ne doivent pas être renouvelées après chaque récolte.
5. Prairies et pâturages permanents - terres consacrées de façon permanente aux herbacées fouragères, cultivées ou sauvages.
6. Forêts et terrains boisés - toutes terres couvertes de végétations naturelles ou artificielles.
7. Autres terres - terres non utilisées mais potentiellement productives, terrains bâtis, terres inutilisables, parcs, routes et toutes autres terres n'entrant pas spécifiquement sous les 4 paragraphes précédents.
8. Les données sur l'irrigation se réfèrent aux superficies irriguées qu'elles l'aient été plusieurs ou une fois l'an.

Tableau 9 est un résumé agricole la plus récente effectuée dans la Caraïbe orientale, Bahamas, Belize et Suriname.

Population

Le Tableau 2 présente, pour la population totale, la population agricole et la population active (total et agricole).

Ces données proviennent généralement des pays.

Les statistiques se rapportent en général à la population dénombrée dans le pays ou territoire à l'intérieur des limites géographiques actuelles (de facto).

Par population agricole, on entend toutes les personnes dont l'agriculture constitue le moyen d'existence.

Par population active, on entend toutes les personnes qui se livrent à une activité économique ou cherchent un emploi.

La population agricole active comprend l'ensemble des personnes occupées économiquement et de manière principale dans l'agriculture, la foresterie, la chasse et la pêche.

Le Produit Interne Brut

L'extrême instabilité observée dans le niveau des taux de change dans certains pays membres du CDCC pendant la dernière décennie ne permet pas de présenter les informations relatives au produit national brut dans une monnaie unique comme dans les éditions précédentes. En conséquence, les tableaux indiquent les données aussi à jour que possible dans les monnaies nationales courantes.

Notas sobre los cuadros

Aprovechamiento de tierras y riego

Los datos corresponden a la información disponible a finales de 1987 y tal vez no representan exactamente el aprovechamiento de tierras y las actividades de riego en una fecha anterior. Las definiciones de las categorías relativas al aprovechamiento de tierras son las siguientes:

1. Superficie total - se refiere a la extensión del país en su totalidad, incluyendo la superficie comprendida por las masas de agua interiores (ríos y lagos principales).
2. Superficie terrestre - se refiere a la extensión total de las tierras, sin incluir las aguas interiores.
3. Tierras arables - comprenden las tierras bajo cultivos temporales, las praderas temporales para corte o pastoreo, las tierras dedicadas a huertas comerciales o pastoreo, las tierras dedicadas a huertas comerciales o huertos y las tierras temporalmente en barbecho o no cultivadas.
4. Tierras dedicadas a cultivos permanentes - se refieren a las tierras dedicadas a cultivos que ocupan el terreno durante largos períodos y no necesitan ser replantados después de cada cosecha.
5. Praderas y pastos permanentes - se refieren al terreno utilizado permanentemente para forajes herbáceos, ya sean cultivados o silvestres.
6. Terrenos forestales y montes - se refieren a las tierras con masas de árboles naturales o plantadas.
7. Otras tierras - comprenden las tierras no utilizadas, pero potencialmente productivas, superficies edificadas, terrenos baldíos, parques, carreteras, caminos y cualesquiera otras tierras que no se hayan incluido en los párrafos 3 a 6.
8. Los datos sobre riego se refieren a las superficies a las que voluntariamente se proporciona agua, independientemente de si estas superficies son regadas varias veces o

solamente una vez durante el año respectivo.

Cuadro 9 resume los resultados del censo agrícola más reciente en los países del Caribe Oriental, Bahamas, Belice, y Suriname. Las estimaciones de la FAO constituyen un intento de reunir datos, para la superficie total de los países, mientras que los censos sólo se refieren a la superficie de las explotaciones.

Población

El cuadro 2 presenta estimaciones de la población total, la población agrícola y la población económicamente activa, total y en la agricultura.

Por lo general, estos datos son facilitados por los países.

Los datos se refieren, en general, a la población presente (de facto) en las zonas respectivas, dentro de las actuales fronteras geográficas.

La población agrícola se define como todas las personas que dependen de la agricultura para su subsistencia.

La población económicamente activa se define como todas las personas dedicadas a una actividad económica o que buscan empleo en ella.

La población económicamente activa en la agricultura comprende todas las personas económicamente activas que se dedican principalmente a actividades agrícolas, forestales, venatorias o pesqueras.

Producto interno bruto

La gran inestabilidad en el nivel de las tasas de cambio y las tendencias inflacionarias observadas en algunos países miembros del CDCC durante el decenio pasado impiden la presentación de la información relativa al Producto Interno Bruto bajo una sola unidad monetaria como se hacía en ediciones anteriores. Consecuentemente, los cuadros relativos presentan, en monedas nacionales corrientes, los datos de lo más reciente posible.




