REFORT OF THE CREDENTIALS COMMITTEE

DRAFT RESOLUTIONS APPROVED BY COMMITTEE 3 (E/CN.12/200, E/CN.12/201, E/CN.12/202)

REPORT OF COMMITTEE 2 (E/CN.12/189

At the invitation of the CHAIRMAN, Mr. RAMIREZ (Guatemala), the Rapporteur of Committee 2, read out the report of that Committee (E/CN.12/189).

The CHAIRMAN suggested that the final approval of that report should be deferred, since the document had not been circulated in time for thorough consideration. Delegations should inform the Rapporteur himself of any changes they wished made.

It was so decided.
