**4. Panel on the challenges faced by middle-income countries ahead of the Second High-level United Nations Conference on South-South Cooperation (Buenos Aires, March 2019)**

Under this agenda item, a panel discussion will be held on the progress made and unmet challenges of South-South cooperation as a regional contribution to the process of producing a draft outcome document to be adopted at the Second High-level United Nations Conference on South-South Cooperation on the occasion of the fortieth anniversary of the adoption of the Buenos Aires Plan of Action, to be held in Buenos Aires from 20 to 22 March 2019. Delegations will also be able to reflect on the challenges faced by middle-income countries and new perspectives on development cooperation in the current economic and social context.
